CALL TO ORDER PLEDGE OF ALLEGIANCE

OATH OF OFFICE: Southern Nevada Board of Health Appointed Member, Richard Cherchio,

RECOGNITIONS

Out-Going At-Large Board of Health Members, Tim Jones, Environmental Specialist, Michael Collins, Registered Nurse and Kenneth Osgood, Physician, where acknowledged for their leadership and devoted service to the Board.

Victoria Harding, SNHD employee and Vice President SNHD SEIU, has read the job descriptions of the District Health Officer (DHO) and Chief Medical Officer (CMO) and believes that the CMO position equates to the current Director of Nursing position. Ms. Harding noted that NRS 632.240 states "Nursing services must be supervised by a chief administrative nurse. The provision of nursing services

in any system for the delivery of health care must be under the direction and supervision of a chief administrative nurse who is a Registered Nurse." The position of CMO has a requirement for a Medical Doctor, not a Registered Nurse. Ms. Harding is concerned that there could be problems if the CMO was also the Director of Nursing. Regarding funding for the positions, the February 2007 Board of Health minutes indicate one person is doing the job of two people, justifying the salary of the Chief Health Officer. Now that the positions are split, Ms. Harding expects the positions to be lower paying positions.

Seeing no one else, the Chair closed this portion of the meeting.

II. ADOPTION OF THE JULY 23, 2015 AGENDA (for possible action)

A motion was made by Member Scow seconded by Member Noonan and unanimously carried to adopt the July 23, 2015 agenda as presented.

Member Tarkanian, Chair of the Nomination of Officers Selection Committee stated the committee met on June 10, 2015 and offered the following recommendations for Officers for the term of July 1, 2015 – June 30, 2016:

Annette Bradley, Attorney, noted that Board Governance Policy indicated officers can only serve a limited time, of which Member Tarkanian would exceed if re-elected. This policy would require temporary waiver for Member Tarkanian to continue as Secretary.

A motion was made by Member Noonan seconded by Member Dobyne and unanimously carried to temporarily waive Board Governance Policy (BGP) to allow Member Tarkanian to continue as an Officer and accept the recommendation from the Nomination of Officers Committee as presented.

The Board reviewed the Resolution of the Southern Nevada District Board of Health Establishing a Public Health Advisory Board and Delegating Certain Authority to the Advisory Board.

A motion was made by Member Dobyne seconded by Member Noonan and unanimously carried to adopt the Resolution of the Southern Nevada District Board of Health Establishing a Public Health Advisory Board and Delegating Certain Authority to the Advisory Board as presented by the Ad Hoc Committee.

Member Noonan announced he had been assigned by Governor Sandoval to the recently formed Southern Nevada Infrastructure Committee for the purpose of evaluating convention facility needs in Southern Nevada. This committee will meet on the same day as the Board of Health and Member Noonan will resign his At-Large seat at the SNHD Board representing the Nevada Resort Association (NRA) effective August 15, 2015. The NRA will be selecting a replacement as soon as possible.

Member Giunchigliani arrived at 9:05 a.m.

The Board asked the District to confirm attendance for the August meeting as soon as possible in order to ensure quorum requirements.

Member Scow reported she attended the recent Community Health Improvement Plan (CHIP) meeting and received very valuable information. She encouraged other elected officials to participate in the District's process.

VII. <u>HEALTH OFFICER & STAFF REPORTS</u>

CHO Comments

Dr. Iser reported the three-year budget projection will be presented at the next Board meeting.

As a result of flash flooding, the water supply in Laughlin was recently deemed unsafe for human consumption and was under a mandatory boil order. This order has since been lifted.

Staff was recently involved in managing the care for a potential Ebola patient. This person was found to be negative. Dr. Iser advised in the future, with the permission of the Board, only the Chair will be advised of these types of on-going issues in order to prevent any possible HIPAA violations.

Jason Frame, Information Technology Manager, presented a brief overview of the Information Technology program.

Andrew Glass, Director of Administration, reported the wall-breaking ceremony occurred on July 22 at the new building site. The full construction crew will be starting today. Scheduled vacancy of 330 S. Valley View is expected in mid-December, total occupation of 280 S. Decatur is expected by January 2016.
