<b>Section 1 – General Provisions</b>	
<b>Major Changes:</b>	<ul style="list-style-type: none"> <li>Unnecessary and unused definitions were removed, and key definitions were added               <ul style="list-style-type: none"> <li>Modified PA Facility definition – added 30+ stay day exemption (pg. 7)</li> <li>Added Short-term Residential Rental as being exempt from PA regs (pg. 9)</li> </ul> </li> <li>Unnecessary Appendixes removed and one added (Table of Contents).</li> </ul>
<b>Section 2 – Substantial Hazards to Public Health and Safety</b>	
<b>Major Changes:</b>	<ul style="list-style-type: none"> <li>None</li> </ul>
<b>Section 3 – Facilities and Equipment</b>	
<b>Major Changes:</b>	<ul style="list-style-type: none"> <li>Plan review requirements were outlined in Section 10.</li> <li>Added language regarding installation of GFCI protection (3.9), disinfection of recirculation systems of whirlpool tubs (3.11.7), prohibition of cellulose sponges (3.11.6) and backflow protection on hose bibbs (3.14.5).</li> </ul>
<b>Section 4 – General Sanitation</b>	
<b>Major Changes:</b>	<ul style="list-style-type: none"> <li>Added language regarding protecting mattresses from contamination with waterproof barriers (4.3.5).</li> </ul>
<b>Section 5 – Pest Control</b>	
<b>Major Changes:</b>	<ul style="list-style-type: none"> <li>Unnecessary and unused language was removed, and the section was restructured.</li> <li>Updated 5.4.1 to reduce the timeframe that facilities must retain pest control records from two years to one year.</li> </ul>
<b>Section 6 – Employees</b>	
<b>Major Changes:</b>	<ul style="list-style-type: none"> <li>Added language to specify handwashing should be conducted in between handling dirty and clean linen (6.3), each employee restroom must have mounted soap, paper towels and hot/cold running water (6.5) and staff that collect ice from publicly accessible ice machines do not need health cards (6.6)</li> </ul>
<b>Section 7 – Food Service and Food Service Facilities</b>	
<b>Major Changes:</b>	<ul style="list-style-type: none"> <li>Added language to clarify that coffee may be provided in a guest lobby without a health permit and if a 3-compartment sink is not available then all coffee cups and other items must be disposable (7.3.3)</li> </ul>

<b>Section 8 – SCRVS Dry Camping at Public Accommodation Facilities</b>  <b>Major Changes:</b> <ul style="list-style-type: none"><li>• Removed Original Section 8 Bed and Breakfast, restructured regulations to have SCRVS in this section</li><li>• Changed from recommendation to requirement the posting of three signs (water, sewage disposal, solid waste disposal) (8.10)</li></ul>
<b>Section 9 - Health Permits</b>  <b>Major Changes:</b> <ul style="list-style-type: none"><li>• None</li></ul>
<b>Chapter 10 – Plan Review and Submission and Approval Date</b>  <b>Major Changes:</b> <ul style="list-style-type: none"><li>• Plan Review requirements outlined with more detail (10.2.2)</li></ul>
<b>Section 11 – Inspections</b>  <b>Major Changes:</b> <ul style="list-style-type: none"><li>• None</li></ul>
<b>Section 12 – Enforcement</b>  <b>Major Changes:</b> <ul style="list-style-type: none"><li>• Changed appeal timeframe from 10 business days to 30 days (12.6).</li><li>• Hearing Officer section updated to mirror Solid Waste and Compliance regulations. (12.7).</li></ul>
<b>Section 13 – Miscellaneous</b>  <b>Major Changes:</b> <ul style="list-style-type: none"><li>• Removed 13.2.3 – SCRVS are already part of the regulations in section 8.</li></ul>
