



Hotels, motels, resorts, hostels, bed & breakfast facilities, transient rooming or lodging houses, and other buildings or structure kept as, used as, maintained as, or held out to the public to be, a place where sleeping or rooming accommodations are furnished to the transient public, require permitting and compliance with **NRS 447** and the **Regulations Governing the Health and Safety of Public Accommodation Facilities**.

### New, Addition or Remodel:

As provided in **Section 3.1**, any person who begins the construction or extensive remodeling of a public accommodation facility that requires a building permit must submit the plans to the appropriate Health Authority for review and approval. At least 30 days prior to beginning construction or remodeling of a public accommodation facility, the responsible person must





## Hotel/Motel

---

Hotels, motels, resorts, hostels, bed & breakfast facilities, transient rooming or lodging houses, and other buildings or structure kept as, used as, maintained as, or held out to the public to be, a place where sleeping or rooming accommodations are furnished to the transient public, require permitting and compliance with **NRS 447** and the **Regulations Governing the Health and Safety of Public Accommodation Facilities**.

### New, Addition or Remodel:

As provided in **Section 3.1**, any person who begins the construction or extensive remodeling of a public accommodation facility that requires a building permit must submit the plans to the appropriate Health Authority for review and approval. At least 30 days prior to beginning construction or remodeling of a public accommodation facility, the responsible person must
