Her presentation included the benefits & features of the Medical Reserve Corps, also explaining who the volunteers were and how they can service medical facilities during

major events (i.e. crisis, emergencies). Ms. Moran gave examples of how MRC helps medical facilities throughout the US. She acknowledged that some of the Southern Nevada facilities requested MRC services during the 2022 COVID surge. She advised that her goal was to have a plan of preparedness and offer services to work with community partners in the Southern Nevada medical arena.



 - Online, in-person


How Other MRCs Help Hospitals



- In Delaware, MRC helped the Eds: vitals, monitoring and moving patients, intake during Omicron surge, especially, refilling supply carts
- New Mexico, MRC is in hospital surge plans across the state: ICU and EDs at IHS hospitals during COVID
- Snohomish Washington State, staffed screening stations at hospital entrances, vitals on some hospital floors
- Massachusetts, MRC nurses and EMTs helped with basic patient care when nursing home patients were evacuated to the general hospital
- Greene County Ohio MRC: full-scale ER exercises, vaccinated staff

- Identify hospital surge needs
- Agreement on credentialing standard
- Develop training plan
- Develop deployment checklist
- Exercise plan
- Train for the next surge
