- A. Presentation and Discussion: Nevada Condom Distribution Plan- Scarlett Cazares See attached presentation titled "Statewide Condom Assessment and Condom Distribution Plan"
 - i. Sample had limitations
 - ii. Acronyms vocabulary
 - iii. Demographics
 - Participants who received free condoms
 - Participants who did not receive free condoms
 - Didn't know they could receive free condoms
 - Didn't know where to get them
 - iv. Comfort Levels with Condoms
 - Access
 - Stores easy access, locked cabinets, no self-check-out

- Mail order Northern NV discontinued their mail order condom program due to funding
- Condom use during sex
- Not using condoms during sex
 - Monogamous relationship
 - Other form of birth control being used
 - Only with new partners
 - They/partner doesn't like them
 - o Not at risk
 - Currently on PrEP
- v. Sexual Healthcare
 - HIV testing (see chart)
 - HIV prevention discussed with provider (see chart)
 - Not asked about sexual history during doctor visits
 - Low awareness of insurance coverage of condoms at pharmacies
- vi. Condom Distribution Plan
 - Short term education/ awareness
 - Medium term colleges (see presentation)
 - Long term condom distribution/ tracking website
- Q: How can we get a copy of the presentation?

A: Presentation is currently in the process of review and approval at NDPBH; however, you can contact Scarlet @ <u>scazares@health.nv.gov</u>

Q: Regarding providers taking a sexual history – the new law is in place; however, providers are unaware, and there are no consequences to not follow the new requirements. How do we address this?
A: Education. During visits to hospitals, while meeting with all providers, in a group of about 50 people, only 4 had heard of PrEP/PEP. Policy education – as legislation is proposed, attach education and dissemination funding/ notifications.

Q: Survey – people who had access to the survey seemed to be in certain pockets of the populations, or at certain events. Could a QR code be assigned to share?

A: The survey reached a diverse range of the population

We would like the survey to continue, but we need academic detailing to be funded.

New campaign with RTC partnership: "She's Well" promotes PrEP among women. This education is also on certain dating websites as well.

With African, African American and Latina culture, women are afraid to ask spouse/ partner to wear a condom.

Women/girls should negotiate with partners to wear condoms during sex. Women/girls should carry condoms. According to the Youth Risk Behavioral Survey – intimate partner violence plays a role in no allowance for condom negotiation. Intimate partner violence was not touched on for this condom survey.

- Education on skill building, sex-ed, condoms, partner violence, "see something, say something," girl power skill sets
- Include all types, sizes of condoms and lube. Information on condom preference was collected and it is a wide range.
- Address/ promote pleasure with condoms it feels good so wear them.

Q: On the HIV testing within the age groups, there wasn't a timeline of testing within one year. Will that be added?

A: It can be added.

- B. 2025 Nevada Legislative Session and Other Policy Recommendations
 - Measure passed in 2021 requiring certain providers to offer/ask patients if they would like to be tested for STIs
 - Modernization measure which decriminalized HIV to a misdemeanor, along with several other measures
 - SB172 in 2023 allowing minors to seek sexual health care, biomedical prevention treatment; PrEP/PEP
 - Services showing on insurance benefits billing Massachusetts has laws to address this, we should review
 - Stigma training next week that will discuss the new laws
 - STI Update next week, but currently at limit; waitlist is available, to put name on list contact Victoria Young at victoriay@med.unr.edu and the EHE agendas.
 - Look for opportunities without funding attached as funding requests are usually passed over
 - NPHA has regular meetings regarding what is happening in terms of legislature and policies.
 - Is there anything coming up State lobbyist has not shared anything; sexual health initiatives are currently not on the legislative agenda
- C. Update on NDPBH Office of HIV Lyell Collins
 - Preston has taken a new position and will no longer be working in the Office of HIV
 - Tory Johnson has also left
 - Coordinator has left
 - Currently hosting interviews to fill these vacancies
 - Lyell Collins will be interim Section Manager
- D. Committees and other NNHPPG and SoN HPPG related activities Proposal for creation of Policy and Media committee
 - Suspended mail order condom project due to budget limitations; 80% of requests came from Clark County; continuing for rural areas, Washoe Cty
 - Look into starting program at SNHD Jen offered data to support the need

 - Moved back to Charleston location
 - Working to develop peer navigators for individuals with HIV testing/treatment, care
 - Navigators will be given a \$250 check, requires certification as per law

 - Planned Parenthood still provides comprehensive sex education synchronized skills, knowledge, negotiation skills for youth
 - Each of us needs to be advocates when we visit providers or the community either in job capacity or personal
 - Health Law Policy 5 major supreme court rulings coming down that may impact public health, reach out to your congressional representatives, we can always provide education and act as private concerned citizens
