



COVID-19 Vaccine Snapshot

Clark County, Nevada

General Notes: This snapshot provides data managed by the Nevada Department of Health and Human Services, Division of Public and Behavioral Health, Immunization Program for Clark County, NV, and assessed by the Southern Nevada Health District's Office of Epidemiology and Disease Surveillance. Due to delays in processing and reporting, data from the most recent date are less complete than data from older dates. For the Johnson & Johnson vaccine, initiation equates to completion. Population estimates are calculated using U.S. Census Bureau; American Community Survey, 2019 American Community Survey 5-year estimates for Clark County. **Data is preliminary and subject to change.** Data was last received on 03/10/2021.

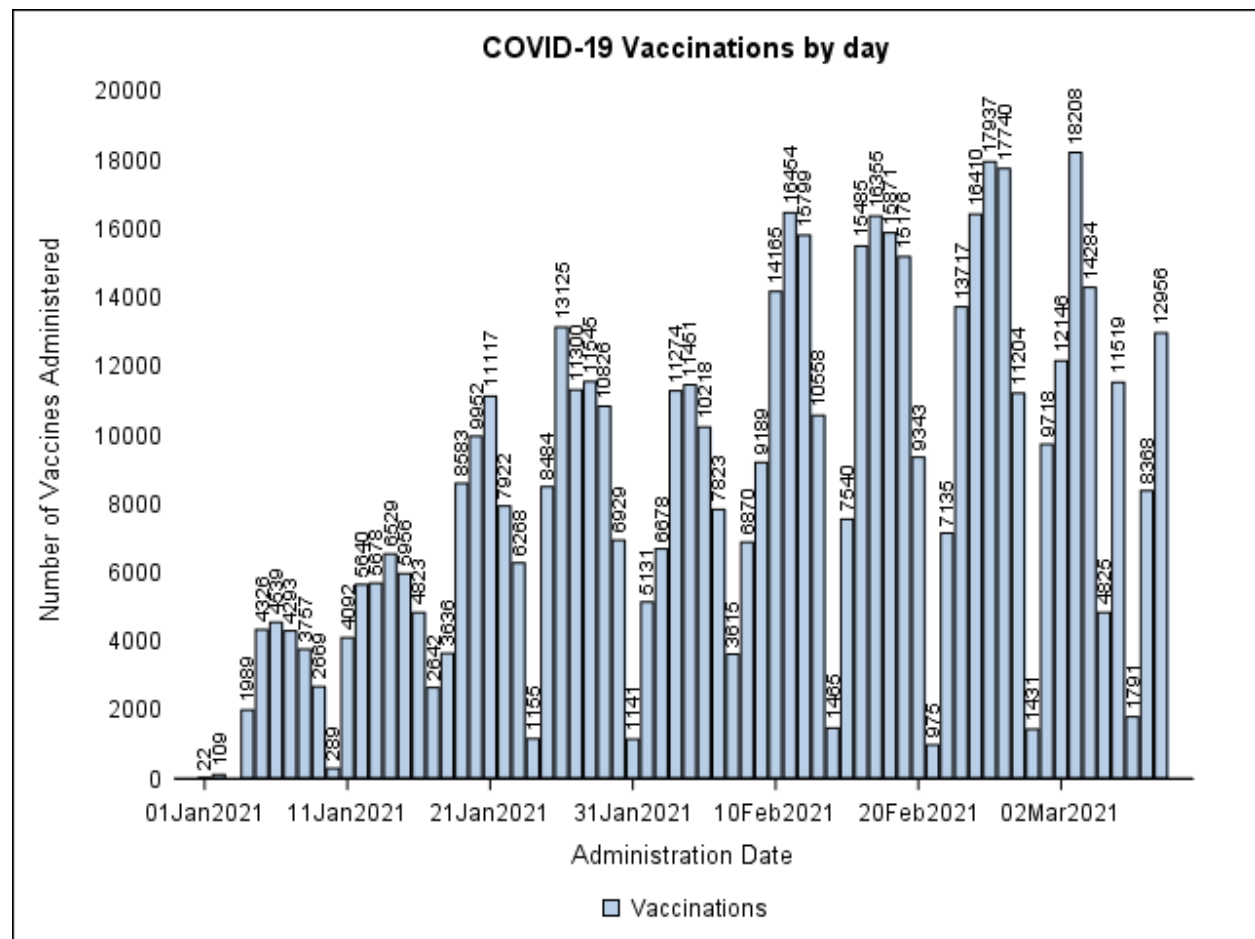

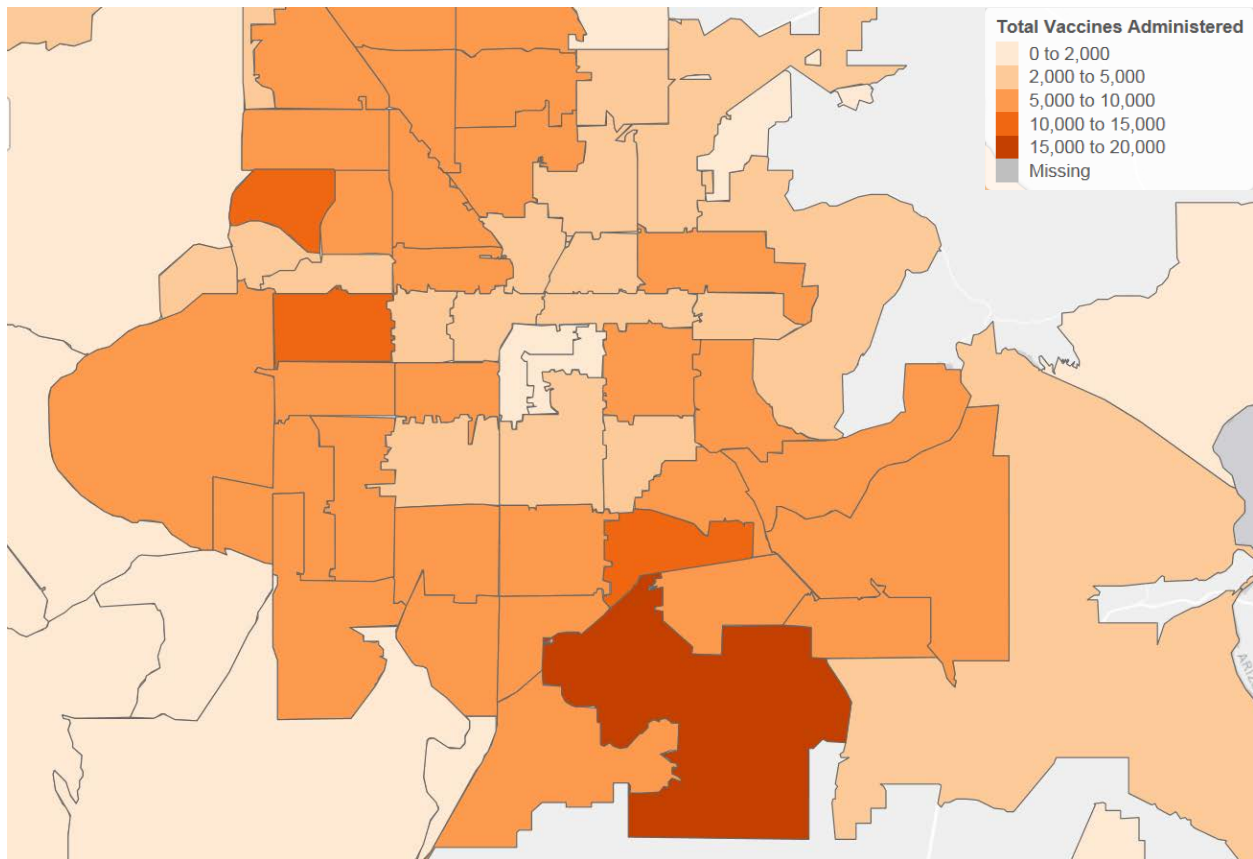
