CALL TO ORDER PLEDGE OF ALLEGIANCE

I. RECOGNITIONS:

- Bonnie Sorenson, Director of Clinics and Nursing Services was recognized by Dr. Iser and staff. Ms. Sorenson is retiring after thirteen years with the District.

III. ADOPTION OF THE OCTOBER 22, 2015 AGENDA (for possible action)

A motion was made by Member Giunchigliani seconded by Member Woodbury and unanimously carried to adopt the October 22, 2015 agenda as presented.

A motion was made by Member Kirkpatrick seconded by Member Nielson and carried unanimously to accept the 2016 Board of Health Meeting Schedule as presented.

2. **Review/Discuss Status of Advisory Board:** direct staff accordingly or take other action as deemed necessary (*for possible action*)

It was determined that the members of the Advisory Board will be invited to the November 19, 2015 Board of Health meeting.

- VII. BOARD REPORTS:** The Southern Nevada District Board of Health members may identify emerging issues to be addressed by staff or by the Board at future meetings, and direct staff accordingly. Comments made by individual Board members during this portion of the agenda will not be acted upon by the Southern Nevada District Board of Health unless that subject is on the agenda and scheduled for action.

In regard to the replacement of the Director of Nursing and Clinical Services position, Member Giunchigliani emphasized the importance of maintaining the current structure and not replacing a nurse with a physician.

Chair Beers asked for clarification on the Board's policy making ability in regard to changing regulations. Dr. Iser explained Environmental Health regulations are generated by the District, approved by the Board, and then approved by the State Board of Health.

Discussion occurred regarding citing the authority of what is being violated during Environmental Health inspections. It was determined that this issue will be agendaized for discussion at the January 2016 Board meeting. The District was asked to provide a list of the top ten to twenty inspection violations to the Board.

Discussion occurred regarding the Environmental Health food regulations. The District is currently working collaboratively with the State Division of Behavioral and Public Health (Joe Pollock), Washoe County and Carson City to establish state wide regulations with the variation for the various jurisdictions. Ms. Reszetar expects to meet with work groups to discuss recommendations in the near future. Ms. Reszetar will send draft food regulations to the Board. Final regulations must be approved by board and State Board of Health. Member Giunchigliani is concerned that small and minority businesses may not be notified and requested a list of invited work groups.

Ms. Reszetar reported the Environmental Health fee structure is being reconfigured by risk level and appropriate fee assessment.

Member Nemec left the meeting at 9:19 a.m. and returned at 9:22 a.m.

Member Kirkpatrick would like future updates on the status of outlying community health centers.

Member Dobyne left the meeting at 9:22 a.m. and returned at 9:24 a.m.

VIII. HEALTH OFFICER & STAFF REPORTS

Dr. Iser updated the Board on the status of the case FBI case of Rick Van Thiel, who was recently arrested for posing as a physician. The District is in the process of checking individuals who were seen by Mr. Van Thiel against the infectious disease data base and there have been some crossovers related to HIV, Hepatitis C and Hepatitis B, however testing has not been done to confirm if the diseases are related to visiting Mr. Van Thiel.

Chief Steinback, the MACC Commander for Operation Rabbit's Foot, will update the Board at the next meeting.

- Deb Williams, Manager, and Aurora Buffington, Registered Dietician, both with the Office of Chronic Disease Prevention and Health Promotion, presented the program overview. **(Attachment 1)** Ms. Williams will provide the top five to ten chronic diseases and causes of death to the Board.
- Paul Klouse, Manager, Environmental Health provided an overview regarding Dogs in Outdoor Dining Areas. **(Attachment 2)**



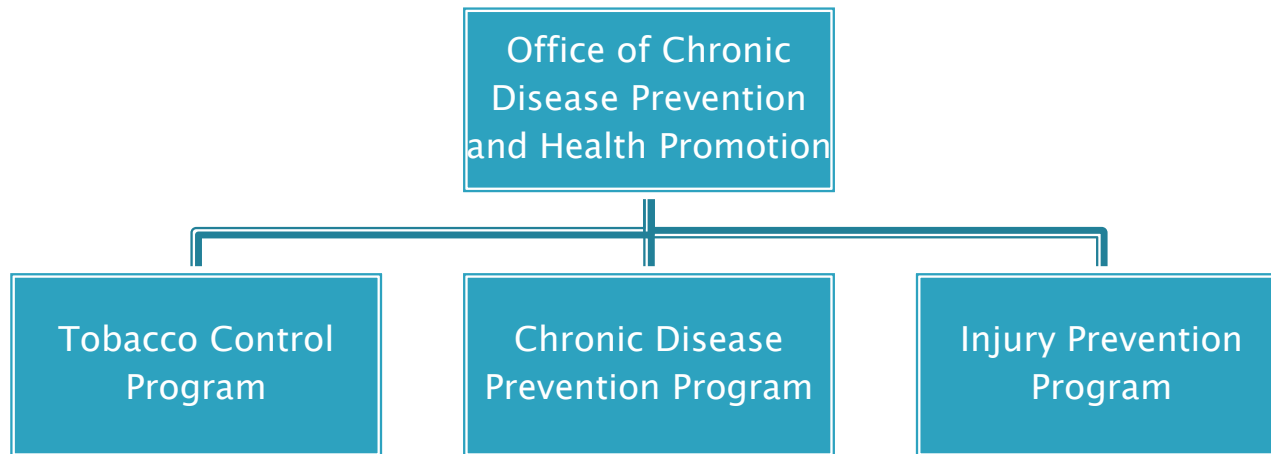

Health Status in Clark County

- ▶ Chronic diseases (heart disease, cancer, stroke) and injuries are among the leading causes of death in the United States and Nevada.
 - Almost 7 out of every 10 deaths in Clark County are attributed to chronic diseases and injuries
 - ▶ The leading risk behaviors contributing to the development of chronic diseases include tobacco use, lack of physical activity, and poor dietary choices.

Leveraging 8010 and Return on Investment

- ▶ Annual investment has leveraged at least \$500K/year in tobacco grant funds
 - ▶ Since 2010 OCDPHP has received about \$25M in direct federal grant funding
 - ▶ Seeing positive changes in health indicators

Changing Our Community – Changing Our Health

- ▶ Highlights from the 2013 Youth Risk Behavior Survey results, CPPW: Southern Nevada Health District High School Survey Trend Analysis Report:
 - In 2013, 8.3% of Clark County high school students were current smokers;
 - In 2010 (pre-CPPW), 12.8%

 - In 2013, 15.6% of Clark County high school students reported drinking a can, bottle, or glass of soda or pop one or more times per day during the past seven days;
 - In 2010 (pre-CPPW), 20.3%

Changing Our Community – Changing Our Health

- ▶ OOE analysis of 3 years of CCSD height and weight data:
 - The percentage of overweight students in the sample decreased from 18.5% (2010/11) to 17.8% (2013/14)
 - The percentage of obese students in the sample decreased from 23.2% (2010/11) to 22% (2013/14)
 - Decreases were seen in both African American and Hispanic students at unhealthy weights in the sample:
AA 41.9% (2010/11) to 39.7% (2013/14)
Hispanic 48% (2010/11) to 45.5% (2013/14)

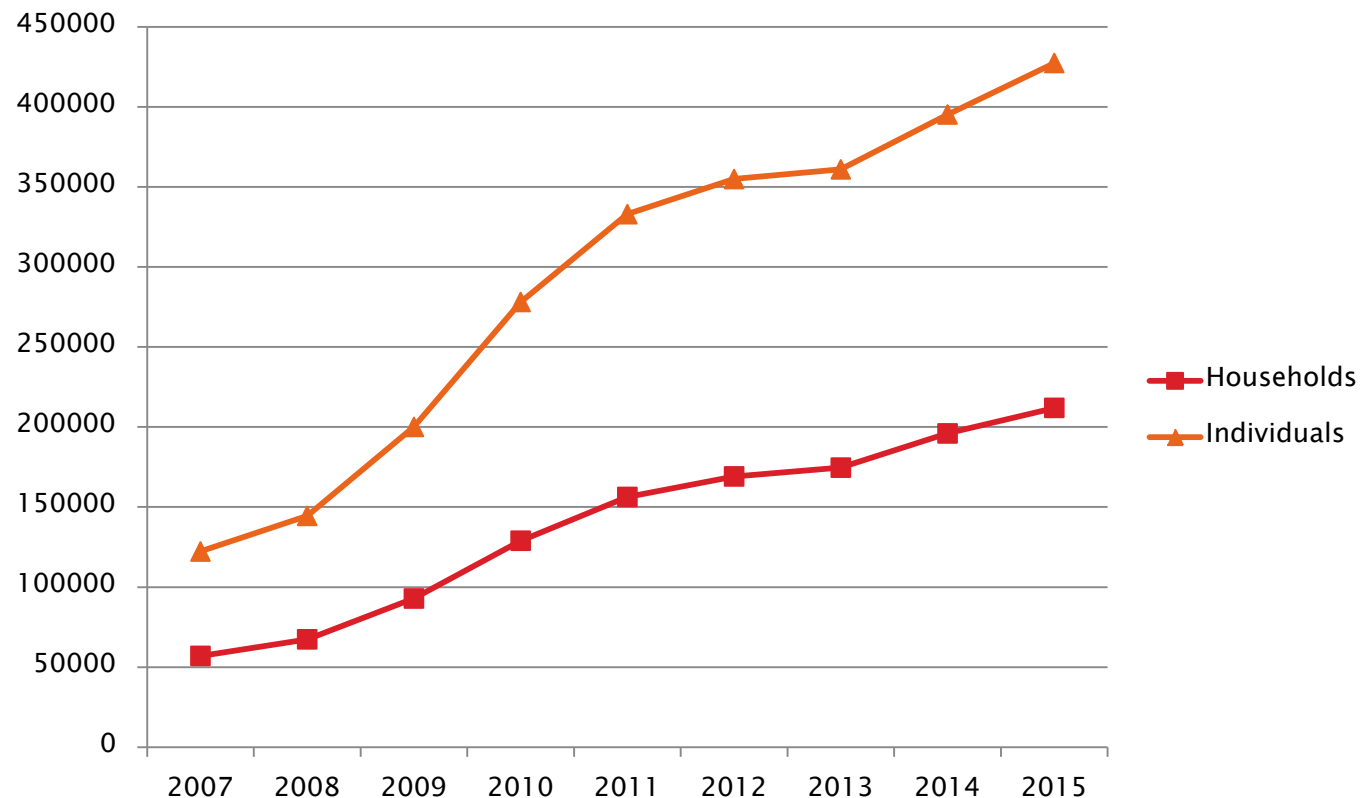

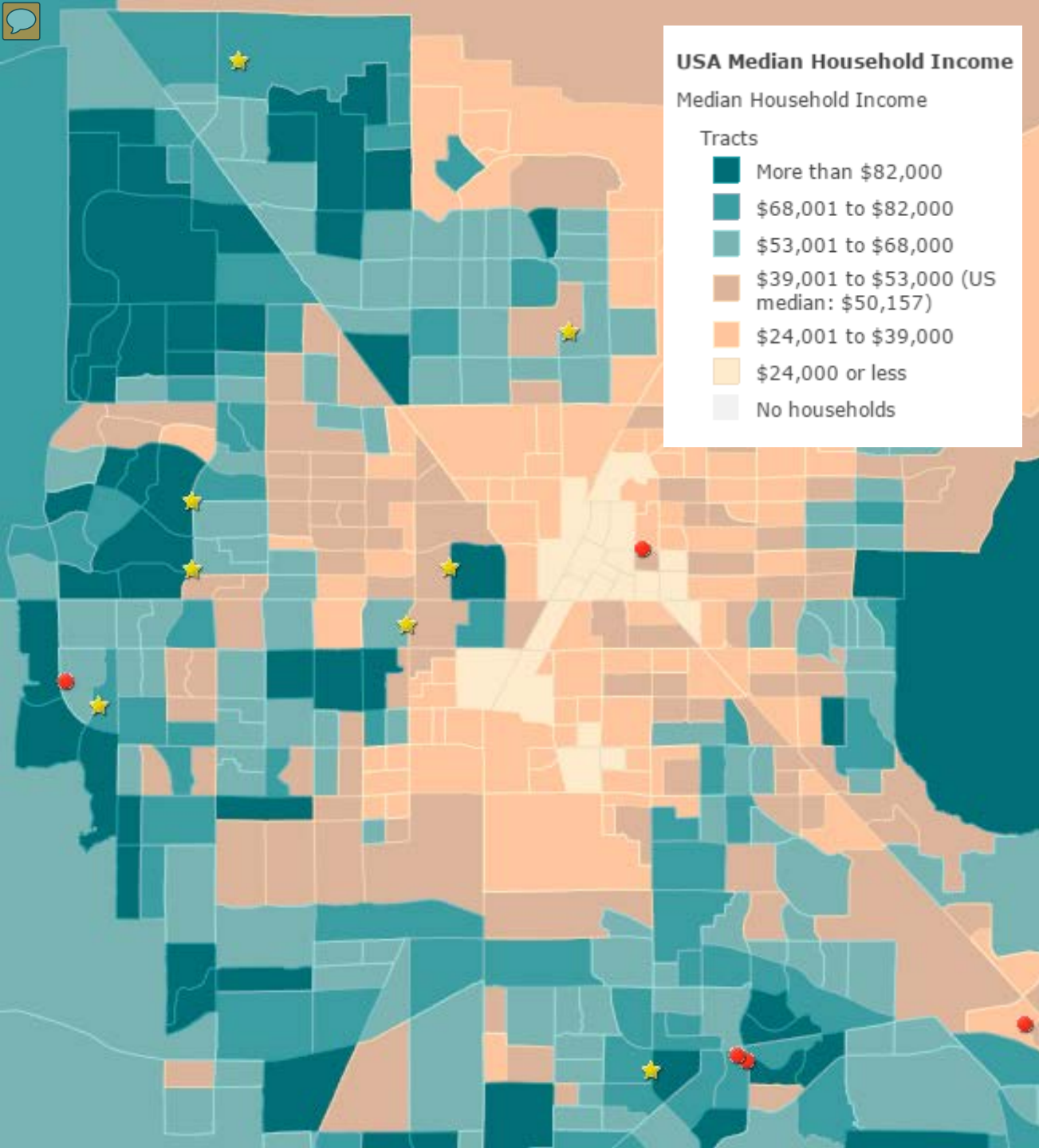

EVOLUTION OF THE DOG-FRIENDLY PATIO



The Problem:

- ◉ FDA Food Code (6-501.115), state & local codes generally prohibit animals;
- ◉ NAC 446.625 & Regulation 6-501.21 prohibits animals on the “premises” of a food establishment, with the premises being defined as “The physical facility, its contents and the **contiguous land or property under the control** of the PERMIT HOLDER...”

-
- ⦿ Animals, except for “Service Animals” as defined by ADA, and security/police dogs, are not permitted on premises;
 - ⦿ Therefore, only Service Dogs (horses) & security/police dogs, are permitted on the patio;
 - ⦿ Does not apply to public right-of-way

Health Risks

- Bacterial – salmonella, e.coli, leptospirosis*, MSRA
 - Viral – H1N1, H5N1
 - Fungal – ringworm, histoplasmosis, cryptococcosis and coccidioidomycosis
 - Protozoan – cryptosporidium & giardia;
 - Roundworms - toxocariasis
 - Hookworms
 - Fleas - Plague
 - Ticks – Lyme Disease, RMSF (bite of vector)
 - Tapeworms - echinococcosis
-
- Spread to dogs and humans through fecal contamination or contact urine*

Zoonotic Risk Factors (CDC):

- ◉ Coming into contact with the saliva, blood, urine, or feces of an infected animal;
- ◉ Being bitten by a tick or mosquito (often called a “vector”)
- ◉ Eating or drinking something unsafe (foods that are contaminated with feces from an infected animal)

The Background:

- Various states, most notably the state of California, City of Denver (CO), City of Dallas (TX), City of Knoxville (TN), Maricopa County (AZ), Summit County (UT) have amended law, created policy, or have provided for Variances to allow for dogs in outdoor areas of restaurants;
- Most register or permit dog-friendly patios in addition to the restaurant, with specific requirements – application / approval process;

GUIDELINES FOR THE ALLOWANCE OF PET DOGS IN OUTDOOR DINING AREAS

There has been interest on the part of restaurant owners and members of the community to allow pet dogs in the outdoor dining areas. As a result of the community interest, Environmental Health assessed the risk factors involved in the allowance of pet dogs in outdoor dining areas. After a meticulous review of supporting data and current Department policy, Los Angeles County Environmental Health made changes to the existing policy to include provisions for the allowance of pet dogs in outdoor dining areas.

Pet dogs may be allowed at the exterior areas in outdoor dining areas of a food facility if the following requirements are met:

- A separate entrance is present where pets do not enter through the food establishment to reach the outdoor dining area.
- No food preparation shall be allowed at the outdoor dining area, including the dispensing/mixing of drinks and ice.
- Customer multi-use or reusable utensils such as plates, silverware, glasses and bowls shall not be stored, displayed or pre-set at the outdoor dining area.
- Food and water served/provided to pets shall only be in single-use disposable containers.
- Employees shall be prohibited from having direct contact with pets while on duty.
- Pets shall not be allowed on chairs, seats, benches, and tables.
- The outdoor dining area shall be maintained clean.
- In cases where excrement or other bodily fluids (urine, saliva, vomit) are deposited, an employee shall immediately clean and sanitize the affected areas.
- The outdoor dining area shall not be fully enclosed (a fully enclosed dining area shall be considered to be part of the interior area of the facility).



* Business operators must still follow local ordinances related to sidewalk, public nuisance, and sanitation issues & State requirements regarding service animals.

The Solution:

- Administrative Waiver – Regulatory Waiver authority was created with the 2010 Food Regulations;
- Allows that staff may waive regulatory requirements, provided the applicant provides documentation and/or agreements that show mitigation of potential or actual health hazards or nuisances;

Elements taken from both LA and Denver documents provide "conditions" for the waiver:

- The waiver applies to only to dogs;
- Dogs may enter the patio area by means of the outdoor patio access only;
- Up to $\frac{1}{2}$ the patio seating and marked;
- Dogs must remain on the floor;
- Doggie treats served in single-service bowls;
- Employees don't touch dogs;
- Employees keep the area clean;
- Employees have a sanitary clean-up kit;
- Accident bags provided for patrons;

Waiver Conditions (cont)

- Applicant understands that the Waiver is part of the permit;
- Applicants understands that the waiver is for food-safety issues only & does not cover dog behavior;
- Applicant understands that nothing in the waiver is meant to address ADA requirements;

Requested from Applicant:

- Application for Waiver;
- FLOOR PLANS showing the patio in relation to the restaurant;
- Rules for Patrons;
- Rules & Procedures for staff;
- Biological Spill Clean-up procedures;
- Menus for Dogs;
- Signed written agreement that the applicant will follow the agreed-upon procedures at all times;

Once reviewed to determine that all elements were in place for the Waiver, a letter granting the Waiver is prepared, signed, and given to the applicant;

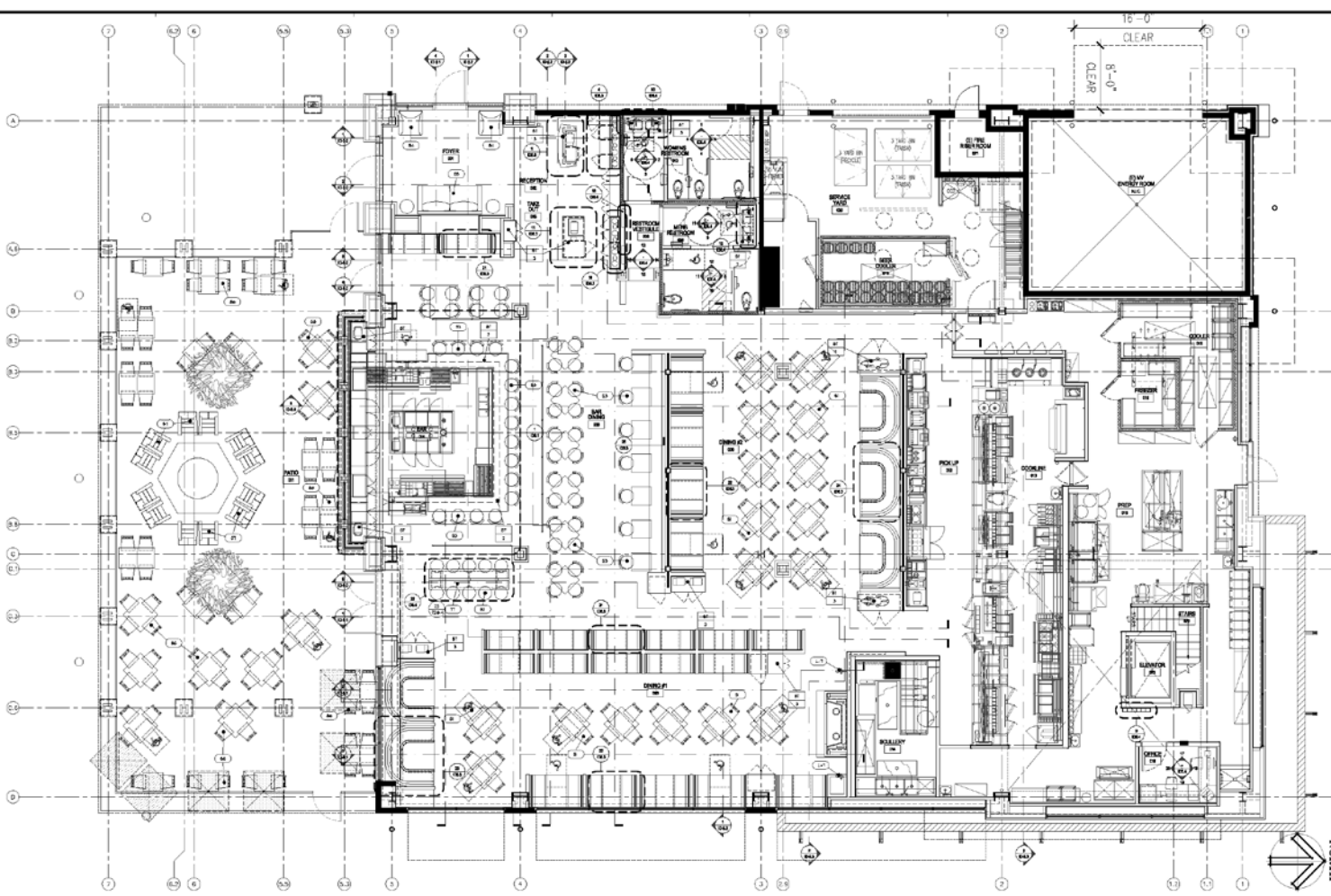

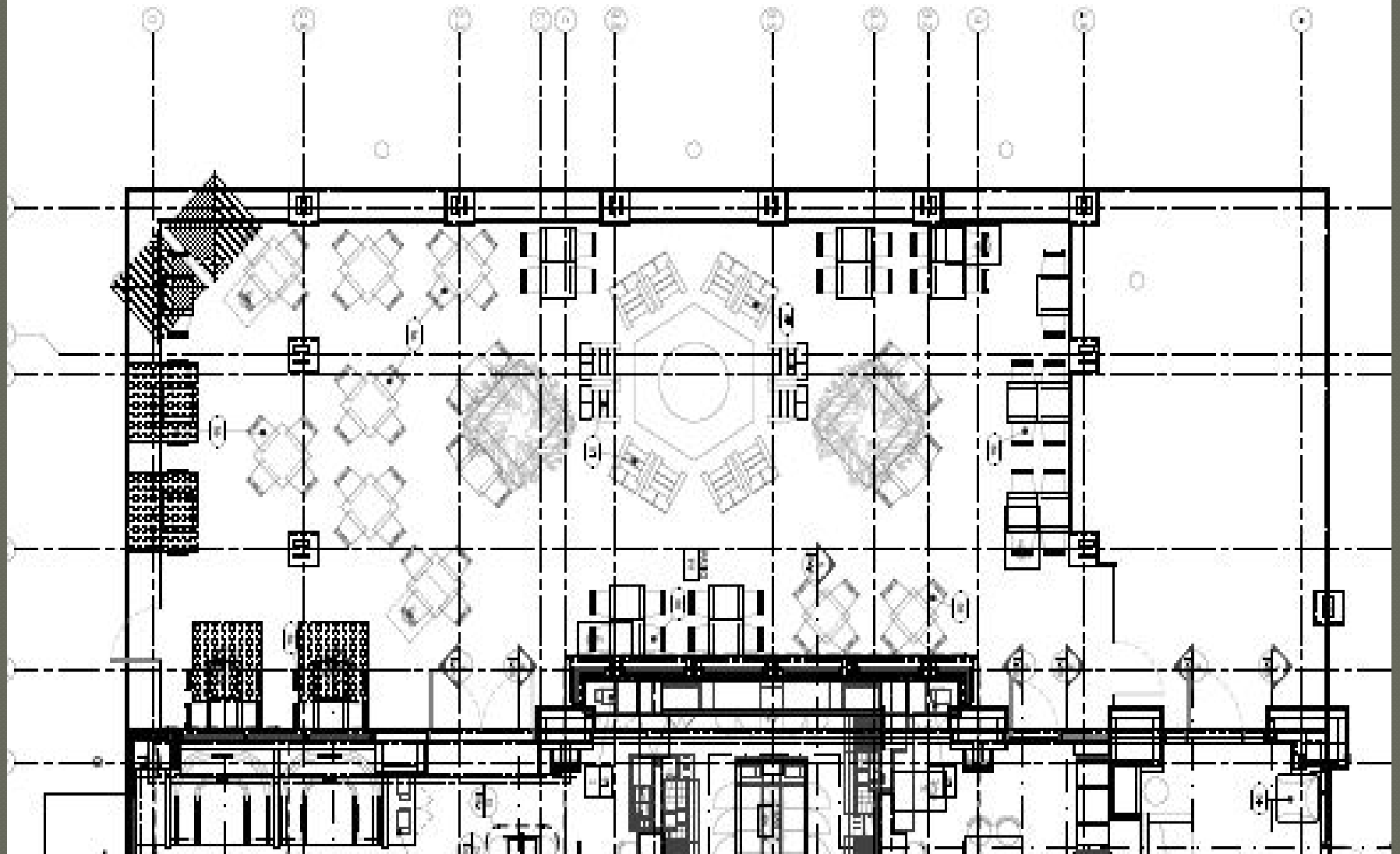
SEATING FLOOR PLAN

3. Remove gelled material with Scoop & Scraper. Carefully place in Red Biohazard Disposal Bag.
4. Use Sanizide plus Germicidal Spray and clean contaminated surface using wiper towel.
5. Place all contaminated materials (including all personal protection and clean up items) in the Red Biohazard Bag. Seal bag, fill out identification tag and attach with twist tie. Dispose of bag into a trash can.
6. Wipe hands with Antimicrobial Hand Wipe. Wash with soap and running water as soon as possible.



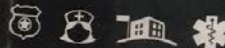

Staff Rules and Procedures for allowing Dogs on the Patio

- No other animals are to be allowed on the patio area, with the exception of service animals and security/police dogs.
- Dogs may enter the patio area by means of the outdoor patio access gate only – dogs and other animals, other than service animals and security/police dogs, will not be allowed inside the restaurant or bar at any time.
- A dog dining area will be segregated from the general patio dining area and marked as such; The area designated will be the area immediately to the right (south) of the west entrance gate of the patio area, and will be restricted to no more than $\frac{1}{2}$ of the available patio dining space.
- All applicant-developed rules and procedures (on table tents) must be adhered to and strictly enforced at all times.
- Dogs must remain on the floor, and may not be allowed on seats, benches, and tables, or other furniture, or to be held by the owner at any time.
- Food and water provided for dogs shall be served only to patrons in single-use disposable containers.
- Restaurant staff/employees may not touch, directly serve, or clean up after a dog allowed on the patio – patrons must be advised that such activities are solely the responsibility of the dog owner.
- After service, staff/employees will use dust pans, mops, and other appropriate means to clean the floor of the patio area.
- In cases where excrement or other bodily fluids (feces, urine, vomit) are deposited on the premises of the patio, a staff member/employee shall immediately provide a disposable waste bag and biological waste clean-up kit (infection control kit) for patrons to use to clean the area.
- Biological waste clean-up/ Infection control kit shall contain disposable apron, eye shield/face mask, shoe covers, nitrile gloves, liquid absorbent, scoop, scraper, disinfectant sanitizer (enough to disinfect 2 square feet of floor); stanchions / cones will be provided to isolate the area while the disinfectant dries.
- A dispenser stand for dog waste bags shall be provided and conveniently placed for patron use.
- This waiver is now a condition of your permit and must remain on premises for review by SNHD staff upon request.
- Nothing in this approval letter shall be construed to be in conflict with the Americans with Disability Act.

Mr. Burdsall:

The Southern Nevada Health District (SNHD) has received your request to waive regulation 6-501.21 "Prohibiting Animals", which prohibits animals, other than service animals and security/police dogs, from the premises of a Food Establishment, on the grounds that the prohibition is unnecessarily burdensome in that it prevents the location at from fully exercising their unique market placement, which allows for dogs and owners to use the outdoor patio area together.

Regulations section 4-101.13 allows that the Health Authority may grant a Waiver by modifying the requirements of the Regulations, if in the opinion of the Health Authority a health hazard or nuisance will not result from the Waiver. During the Waiver process, the Health Authority may impose conditions upon the Waiver. If a Waiver is granted, the Health Authority shall retain the information in its records for the Food Establishment. Failure to meet conditions of the Waiver may result in immediate revocation of the Waiver.

Section 6-501.21 allows only service animals and security/police dogs to be upon the premises of a food establishment, with the "premises" defined as including the "...physical facility, its contents and the contiguous land or property under the control of the PERMIT HOLDER..." Both Nevada Administrative Code 446.625, as well as SNHD regulations 6-501.21, contains the same prohibition, which is derived from the FDA 2013 Model Food Code language in section 6-501.115. During a cursory search for literature regarding transmission of food-borne illness related to dogs allowed within food establishments, however, staff was unable to locate any published reports linking dogs in restaurants to food borne illness outbreaks. Numerous examples were found that would indicate a trend of state and local health authorities allowing outdoor patio access for pets.

Based upon the limited scope of this request, the sanitation procedures provided by the applicant and the absence of scientific evidence to the contrary, your request is **APPROVED** subject to the following operational permit conditions:

- The request for waiver only applies to dogs (*Canis familiaris*). No other animals are allowed on the patio area, with the exception of service animals and security/police dogs;
- Dogs will only access the patio area by means of the outdoor patio gate only - dogs, other than service animals
- and security/police dogs, will not be allowed inside the restaurant or bar at any time;

- The dog dining area will be segregated from the general patio dining area and marked as such, and will be restricted to no more than 1/2 of the available patio dining space;
- All restaurant-published rules and procedures will be adhered to and strictly enforced at all times;
- Dogs must remain on the floor, and may not be allowed on seats, benches, and tables, or other furniture, or to be held by the owner at any time;
- Restaurant staff/employees will not touch, directly serve, or clean up after a dog allowed on the patio - patrons will be advised that such activities are solely the responsibility of the dog owner;
- In cases where excrement or other bodily fluids (feces, urine, vomit) are deposited on the premises of the patio, a staff member/employee shall immediately provide a disposable waste bag and customer clean up kit to use to clean the area;
- Waste clean-up kit will contain nitrile gloves, liquid absorbent, scoop, scraper to be used to remove soil matter;
- Staff will maintain a final clean-up kit containing disinfectant, mops and other tools to complete the clean-up and Disinfection of the area - these tools will not be used for other purposes; Staff will wash hands after clean-up;
- Stanchions / cones will be provided to isolate the area while the disinfectant dries;
- A dispenser stand for dog waste bags shall be provided and conveniently placed for patron use;
- The permittee understands and agrees that conditions under which a waiver is granted are considered conditions of the health permit, and failure to maintain such conditions after approval is grounds for permit suspension.
- The permittee understands and agrees that nothing in the conditions of an approved waiver may be interpreted or construed to be in conflict with the Americans with Disability Act.
- The permittee understands and agrees that approval of any such waiver is not expressed or intended to address safeguards to potential animal behavior - damage to persons and animals related to animal interactions are the sole responsibility of the applicant.

Approval of this waiver indicates the SNHD believes adequate safeguards are in place to prevent transmission of food-borne illness related to dogs on the patio of the premises. This waiver does not address safeguards to potential animal behavior - damage to persons and animals related to animal interactions are beyond the scope of this waiver and are the sole responsibility of the applicant;

It is understood that any documented failure of the permit holder to meet or maintain the operational permit conditions as noted above will be considered grounds for immediate revocation of this waiver approval and the immediate suspension of the underlying health permit.

This Waiver is automatically terminated without further notice upon the closing of any sale transaction involving the subject health permit.
