Consulting Agreement

THIS CONSULTING AGREEMENT (the "Agreement") is made and entered into this 13th day of April 2016 the "Effective Date")

By and between

Lunas Construction Clean Up, Inc. a Nevada corporation duly organized under law and having a usual place of business at 4830 E. Cartier Ave Las Vegas, NV 89115 (hereinafter referred to as the

"Company")

And

Doug Dobyne (hereinafter referred to as the "Consultant").

WHEREAS, the Company wishes to employ the advisor to offer the services described herein and Consultant makes agreement to provide the services for the reimbursement and otherwise in harmony with the terms and conditions of this Agreement,

NOW THEREFORE, in consideration of the prior, and for other good and valuable consideration, the receipt and adequacy of which are hereby recognized, acknowledged and approved to, the Company and the Consultant, aiming to be officially bound, agree to the terms set forth below.

1. TERM. Beginning as of the Effective Date, and enduring for a period of 24 months (the "Term"), unless prior finished pursuant to mutual agreement hereof, the Consultant makes agreement that he/she will serve as a consultant to the Company. This Agreement may be changed or extended for any period as may be agreed by the parties.

2. DUTIES AND SERVICES.

(a) Consultant's duties and responsibilities shall be to advise and perform certain project work that relates to the companies Material Recovery Facility and Recycling Center. No work will be scheduled with specific written request from the Company. In addition consultant will continue to represent my industry as a Member of the Board for the Southern Nevada Health District.

(b) The Company will occasionally offer the Consultant with a schedule of the requested hours, responsibilities and deliverables for the pertinent period of time. The duties will be scheduled on an as-needed basis.

(c) In performing the Services, Consultant shall obey, to the best of his/her information, with all business manners, regulatory and health and safety guidelines recognized by the Company for any governmental power with respect to the Company's business.

3. CONSULTING FEE:

(a) According to the agreement terms hereof, the Company shall pay Consultant a consulting fee based on an agreed upon project basis (the "Consulting Fee"). The Consulting Fee shall be paid within 30 days of the Company's receipt of the report and invoice.

(b) Consultant shall be permitted to prompt repayment for all pre-approved expenses made in the performance of his/her Duties, on submission and endorsement of written statements and receipts

(c) Consultant makes agreement to pay all taxes including, self-employment taxes due in respect of the Consulting Fee and to indemnify the Company in the event the Company is required to pay any such taxes on behalf of the Consultant.

4. PERFORMANCE STANDARD: Consultant represents and warrants that the Services will be performed in good faith, in a manner it believes to be in the best interests of Company, and with such care, including reasonable inquiry, as an ordinarily prudent person in a like position would use under similar circumstances. Consultant is entitled to rely on information, opinions, reports or statements, including financial statements and other financial data, prepared or presented by counsel, independent accountants or other persons as to matters which Consultant believes to be within such person's professional or expert competence, so long as Consultant, in each such case, acts in good faith, after reasonable inquiry and without knowledge that would cause such reliance to be unwarranted. Company's sole remedy for a failure by Consultant, or if Company believes that Consultant has failed, to meet this Performance Standard, is the termination of this Agreement.

5. AMENDMENTS: This Agreement may be altered or customized, in whole or in part, only by an instrument in writing approved by all parties hereto. Any adjustment, permission, verdict, waiver or other action to be made, taken or given by the Company related to the Agreement shall be made, taken or given on behalf of the Company only by power of the Company's Board of Directors.

6. NOTICES: Any notices or other communications required hereunder shall be in writing and shall be considered given when distributed in person or when posted, by qualified or registered first class mail, postage prepaid, return receipt requested, addressed to the parties at their addresses mentioned in the foreword to this Agreement or to such other addresses of which a party shall have notified the others in harmony with the provisions of this clause.

7. COUNTERPARTS: This Agreement may be executed in two or more complements, each of which shall comprise an original and all of which shall be considered a single agreement.

8. GOVERNING LAW: This Agreement shall be construed in accordance with and governed for all purposes by the laws of the State of Nevada applicable to contracts.
