## Influenza Update

The Southern Nevada Health District began offering influenza vaccine to the public in September and continues to encourage everyone 6-months and older to get vaccinated. The Centers for Disease Control and Prevention (CDC) estimates that flu vaccinations prevented 71,000 flu hospitalizations during the 2015-16 influenza season and that it will prevent 2.5 million flu-related medical visits and 5 million illnesses during this season.

As of week 43 of the current season (Oct. 28, 2017), there have been 13 cases reported to the Health District, with six of those being hospitalized. No deaths have been reported. The CDC is reporting that seasonal flu activity remains low overall in the United States. ## Accreditation Update

The Mobile Health Collaborative held its second event on October 20 at Whitney Recreation Center. Partners included Health Plan of Nevada, Touro University, Three Square, UNLV, the Mexican Consulate/Ventanillas de Salud, and Dignity Health. Services offered at the event ranged from primary care, behavioral health and addiction information, immunizations, dental and vision screenings, Medicaid enrollment assistance, and housing information. More than 200 families received services at the event. The Mobile Health Collaborative is a direct result of the Community Health Improvement Plan's Access to Healthcare priority group, a key piece of the accreditation process.

Tamara Bannan has been selected as the Accreditation Consultant for the Health District. Ms. Bannan was the Accreditation Coordinator for San Diego County from 2009 to 2015 and continues to provide technical assistance to other health departments on the topic of public health accreditation. Also, she has served as a Public Health Accreditation Board site visitor. Ms. Bannan will work with Health District staff and its accreditation team to prepare for the submission of appropriate documents. Ms. Bannan will also review the process that the Health District is using as part of its accreditation efforts to help the Health District successfully achieve Public Health Accreditation. In her role as

Accreditation Consultant, she will provide the Health District with an action plan, if necessary, as the February 2018 submission date nears.
