RE: Approve Amendment to Interlocal Space Lease Agreement between Public Agencies

That the Southern Nevada District Board of Health approves the Third Amendment to the Interlocal Space Lease Agreement between Henderson City Hall and the Southern Nevada Health District.

DISCUSSION:

The Health District has leased space at the City of Henderson City Hall for three years (January 1, 2017 – December 31, 2019). The leased space is used to allow the Health District to distribute Food Handler Cards. The leased space is 345 square feet, located in the Development Services Center in Henderson City Hall (240 Water Street). Term is for the fourth year of the lease, January 1, 2020 – December 31, 2020.

FUNDING:

\$293 per month (\$.85 per square foot) or \$3,516 per year, including utilities.

THIRD AMENDMENT TO INTERLOCAL SPACE LEASE AGREEMENT

Henderson City Hall Southern Nevada Health district C1800033 CMTS# 20510

This Third Amendment to Interlocal Space Lease Agreement ("Third Amendment") is effective as of January 1, 2020, by and between City of Henderson, a municipal corporation and political subdivision of the State of Nevada ("Lessor"), and Southern Nevada Health District, a political subdivision of the State of Nevada, ("Lessee") (collectively "Parties"):

RECITALS

- A. The Parties entered into that certain Interlocal Space Lease Agreement effective as of January 1, 2017 (the "Lease"), pursuant to which Lessor leased to Lessee and Lessee leased from Lessor approximately three hundred forty-five (345) square feet of office space, located in the Development Services Center in Henderson City Hall, located at 240 Water Street, Henderson, Nevada 89015; and
- B. The term of the Lease was for a period of one (1) year with an option to renew for three (3) additional one-year periods upon mutual agreement of the Parties; and
- C. The Parties executed a First Amendment to Interlocal Space Agreement effective January 1, 2018, exercising the first of three (3) one-year options to extend the Initial Term pursuant to Paragraph 3 of the Lease; and
- D. The Parties executed a Second Amendment to Interlocal Space Agreement effective January 1, 2019, exercising the second of three (3) one-year options to extend the Initial Term pursuant to Paragraph 3 of the Lease; and
- E. Lessee desires to exercise the third of three (3) one-year options to extend the Initial Term pursuant to Paragraph 3 of the Lease and, in connection therewith, the Parties desire to provide for such Extension Term and the amendment of the Lease as more fully set forth herein.

NOW THEREFORE, in consideration of the mutual promises herein contained, the Parties agree to the following as of the effective date of this Third Amendment shown above:

- 1. The Extension Term of this Agreement is one (1) year, beginning January 1, 2020 at 12:00 a.m. and terminating on December 31, 2020 at 11:59 p.m. (the "Third Extension Term").
- 2. As Lessee is exercising the third of the three (3) one-year options to extend the Initial Term under the Lease, Lessee hereby acknowledges and agrees that as of the effective date of this Third Amendment, no such option to extend remains.
- 3. All other terms and conditions of the Agreement shall remain unchanged.
