Subject: Presentation of the Business Impact Statement for the Proposed Environmental Health Fee Schedule Adjustments

I. BACKGROUND:

The Health District is responsible for state-mandated environmental health permitting and inspections in Clark County, Nevada. Some examples of Health District environmental health permits include permanent and temporary food operations; pools and spas; public accommodations; schools; childcare facilities; body art and tattoo shops; underground storage tanks; individual sewage disposal systems; and liquid waste haulers.

The EH division of the Health District has not had an overall fee adjustment approved by the Board of Health since 2009. As a result, permit fees have not changed while operating costs have increased. Please note, the Consumer Price Index has increased 33% over this same period of time.

On March 25, 2022, the EH division issued public notice of the Business Impact Survey. The proposed EH Fee Schedule included a 29% increase to all, but statutorily set, program fees. Based upon business input, the EH division removed the Vector Control program from the proposed increases. This caused a decrease of 2% in the calculated fees.

II. PROPOSED ADJUSTMENTS:

The Health District proposes the following EH Fee Schedule adjustments effective July 1, 2022:

1. 27% fee increase to all fees on the EH Fee Schedule.
2. Tie the EH Fee Schedule to the Consumer Price Index (Western Region) with an annual adjustment of a 1% floor and a 3% ceiling beginning July 1, 2023.

These EH Fee Schedule adjustments will allow programs to keep up with increasing operating costs and continued community growth.

The proposed changes are projected to increase EH division revenue by \$5,465,781 in Fiscal Year 2023 (July 1, 2022 to June 30, 2023) and between 1-3% annually thereafter based on the Consumer Price Index.

III. RECOMMENDATION:

The Health District recommends approval of the Business Impact Statement for the proposed EH Fee Schedule adjustments. With recommendation, staff will move forward with the presentation of the proposed EH Fee Schedule adjustments at the May 26, 2022, Board of Health meeting.

BUSINESS IMPACT STATEMENT ENVIRONMENTAL HEALTH FEE SCHEDULE ADJUSTMENTS

Pursuant to Nevada Revised Statutes (NRS) 237, the following information has been prepared.

SECTION A - A DESCRIPTION OF THE MANNER IN WHICH COMMENT WAS SOLICITED FROM AFFECTED BUSINESSES, A SUMMARY OF THEIR RESPONSE, AND AN EXPLANATION OF THE MANNER IN WHICH OTHER INTERESTED PERSONS MAY OBTAIN A COPY OF THE SUMMARY

Comment was solicited in the following ways:

1. The Business Impact Survey notification was emailed to 14,666 Environmental Health permit contacts.
2. The Business Impact Survey notification was faxed and/or emailed to the following jurisdictions for posting at their offices: Henderson City Hall, Boulder City's City Hall, Mesquite City Hall, North Las Vegas City Hall, Las Vegas City Hall, Clark County Manager's Office, and Laughlin Community Resource Center.
3. The Business Impact Survey notification was mailed or emailed to the following associations: Armed Forces Chamber, Korean American Chamber of Commerce LV, Las Vegas Asian Chamber of Commerce, Boulder City Chamber of Commerce, Henderson Chamber of Commerce, Las Vegas Metro Chamber of Commerce, Las Vegas Wedding Chamber of Commerce, Latin Chamber of Commerce, Laughlin Chamber of Commerce, Mesquite Chamber of Commerce, Sin City Chamber of Commerce, Spring Valley Chamber of Commerce, Urban Chamber of Commerce, Women's Chamber of Commerce, Dairy Council of Nevada, Nevada Food Safety Task Force, Nevada Hotel and Lodging Association, Nevada Restaurant Association, Nevada Resort Association, and the Retail Association of Nevada.
4. The Business Impact Survey notification was emailed to individuals that have previously expressed interest in Environmental Health Fee Schedule adjustments.
5. The Business Impact Survey notification was given to operators of permitted commissaries for posting at their facilities.

6. SNHD held a Listening Session, in-person and via WebEx, on April 7, 2022, to gather data and comments from the public.
7. An Environmental Health Fee Schedule presentation was given to the Public Health Advisory Board on April 11, 2022.

During the comment period ending on April 15, 2022, the Health District received 106 responses. Thirty respondents said that the EH Fee Schedule adjustments would have no impact on their business.

SECTION B - THE ESTIMATED ECONOMIC EFFECT OF THE PROPOSED RULE ON THE BUSINESSES WHICH IT IS TO REGULATE, INCLUDING, WITHOUT LIMITATION:

Adverse Effects:

- Businesses will pay more for services provided.

Beneficial Effects:

- Increased fees will be used to hire additional EH staff which will reduce customer wait times for permit processing, appointments, and inspections.
- Increased fees will be used to hire dedicated staff for unpermitted food vending, as requested by the community.
- Increased fees used for additional staff will allow SNHD to meet mandated inspections.
- Businesses will obtain timelier services due to increased EH staffing.
- Additional staff can help prevent community outbreaks that could negatively affect tourism.

Direct Effects:

- Businesses will have to pay 29% more for EH services provided.

Indirect Effects:

- Businesses subject to EH permitting, who service other businesses that are also subject to EH permitting, might pass increased costs to these other businesses.
- Permitted businesses may pass increased costs to consumers.

SECTION C - A DESCRIPTION OF THE METHODS THAT THE GOVERNING BODY OF THE LOCAL GOVERNMENT OR ITS DESIGNEE CONSIDERED TO REDUCE THE IMPACT OF THE PROPOSED RULE ON BUSINESSES AND A STATEMENT REGARDING WHETHER THE GOVERNING BODY OR ITS DESIGNEE ACTUALLY USED ANY OF THOSE METHODS

SNHD considered splitting the increase over two years but decided against it due to the large budget shortfall, increased demand for services, and immediate need for additional staffing.

SECTION D - THE ESTIMATED COST TO THE LOCAL GOVERNMENT FOR ENFORCEMENT OF THE PROPOSED RULE

The proposed EH Fee Schedule adjustments will not create a material administrative investment to enforce.

SECTION E - IF THE PROPOSED RULE PROVIDES A NEW FEE OR INCREASES IN EXISTING FEE, THE TOTAL ANNUAL AMOUNT THE LOCAL GOVERNMENT EXPECTS TO COLLECT AND THE MANNER IN WHICH THE MONEY WILL BE USED

The Environmental Health (EH) division of the Health District has not had an overall fee adjustment approved by the Board of Health since 2009. As a result, permit fees have not changed while operating costs have increased. Please note, the Consumer Price Index has increased 33% over this same period of time.

The EH division is anticipating a \$3 million shortfall and has a need to keep up with growth in the community. Overall, permits have steadily increased since 2011, and additional staff is needed to be able to meet mandated inspection requirements and continue to provide good customer service. EH and Finance staff calculated that a 29% adjustment to current fees would provide the necessary financial resources to break even and meet community needs.

The Health District proposes the following EH Fee Schedule adjustments effective July 1, 2022:

1. 29% fee increase to all fees on the EH Fee Schedule.
2. Tie the EH Fee Schedule to the Consumer Price Index (Western Region) with an annual adjustment of a 1% floor and a 3% ceiling beginning July 1, 2023.

The proposed changes are projected to initially increase EH division revenue by \$5,870,654 in Fiscal Year 2023 (July 1, 2022 to June 30, 2023) and between 1-3% annually thereafter based on the Consumer Price Index. Funds will be used to reduce the budget shortfall in Environmental Health and hire additional staff.

SECTION F - IF THE PROPOSED RULE INCLUDES PROVISIONS WHICH DUPLICATE OR ARE MORE STRINGENT THAN FEDERAL, STATE, OR LOCAL STANDARDS REGULATING THE SAME ACTIVITY, AN EXPLANATION OF WHY SUCH DUPLICATIVE OR MORE STRINGENT PROVISIONS ARE NECESSARY

The proposed EH Fee Schedule adjustments are not duplicate or more stringent than Federal, State, or local standards.

SECTION G - THE REASONS FOR THE CONCLUSIONS REGARDING THE IMPACT OF THE PROPOSED RULE ON BUSINESSES

SNHD has concluded that although there may be an economic impact on some businesses, the approval of the proposed EH Fee Schedule adjustments is not likely to impose a direct and significant economic burden upon businesses or directly restrict the formation, operation, or expansion of businesses. Permit fees are paid annually.

Pursuant to NRS 237.090, the BOH will hold a PUBLIC HEARING considering this Business Impact Statement at a virtual meeting on Tuesday, May 3, 2022, at 2:00 p.m. The BOH will review and consider approval of the proposed Environmental Health Fee Schedule adjustments at a PUBLIC HEARING on Thursday, May 26, 2022, at 9:00 a.m. virtually and at 280 South Decatur Boulevard.

Summary of Business Impact Statement Surveys/Comments Proposed Environmental Health Fee Schedule Adjustments

Comment Period: March 25, 2022 through April 15, 2022

Total Respondents: 106

Will the proposed Environmental Health (EH) Fee Schedule adjustments impose a direct and significant economic burden upon your business?

Yes = 69 Respondents

Estimated Monetary Impact by Respondents without High Dollar Outliers = \$0.50 - \$5,000

SNHD Research on Outliers:

- One respondent estimated an impact of \$10,000 due to the facility already struggling to operate. The permit fees for this facility will increase \$209.
- One respondent estimated an impact of \$16,300 due to large increases in the cost of goods. SNHD believes that this is a reasonable estimate for the cost of the 119 permits at this facility.
- One respondent estimated an impact of \$40,000 due to increased operating costs. SNHD believes that this is a reasonable estimate for the 479 permits under this corporation.
- One respondent estimated an impact of \$120,000 due to grocery suppliers passing increased costs onto vendors. The permit fees for this business will increase \$322.48, but it is unknown if, or by what amount, the EH fee adjustments will impact the cost of goods for a business.
- One respondent estimated an impact of \$650,000 due to COVID. The permit fees for this business will increase \$262.28.

Estimated Monetary Impact by Respondents = \$350

Do you anticipate any indirect economic effects to your business as a result of the proposed EH Fee Schedule adjustments?

Estimated Monetary Impact by Respondents without High Dollar Outliers = \$100-\$3,000

Outliers:

- One respondent estimated an impact of \$10,000 due to impacts to daily operations and increased fees would restrict expansion.
- One respondent estimated an impact of \$20,000 due to a trickle-down effect that will affect the entire operation.
- One respondent estimated an impact of \$120,000 due to grocery suppliers passing increased costs onto vendors.

Summarized Main Comments:

- Some respondents agreed with the increase to keep the public safe and maintain high standards as long as there were no additional regulatory burdens.
- There is a beneficial impact if fee increases will be used to search and shut down unpermitted operators.
- A small increase would be better than a 30% increase or a reduction in services.
- A 10-15% increase in fees is reasonable and there should be harsher penalty fees.

- Some respondents wanted more time before proposed fee changes become effective and/or phased increases.
- Costs have already increased for rent, fuel, delivery, food, goods, labor, imports, electric, and other agency fees.
- Business are still trying to recover from the pandemic; many are not back to pre-pandemic profitability.
- Businesses with small profit margins may go out of business.
- Businesses will pass the increased costs to their vendors and consumers.
- Consumers are less willing to spend money and will only pay so much for goods.
- Operating/overhead costs will increase.
- Adding increased fees to facilities with multiple permits is a significant burden.
- All increases pose a burden to businesses and could make expanding difficult.
- Fees are already too high.
- There should be internal agency cost reductions to help offset the budget deficit and reduce increased fees.
- If there's no increase in the level of service, there's no justification for an increase in fees.
- If penalty fees are increased, there is a concern that they will be used as a taxation tool.
- Now is not the time to raise fees. It will make it harder for businesses to recover from the pandemic.
- Some respondents did not want the fees tied to the Consumer Price Index.
- Some respondents wanted targeted fee increases and did not want unfunded programs included in expenses.
- Some respondents wanted the proposed fees compared to other jurisdictions.

RE: Environmental Health Fee Increase

Dear Director Saxton:

I write today to share comments regarding the proposed environmental health fee increase on behalf of the nearly 65 Southern Nevada resort hotel properties that the Nevada Resort Association represents. Please accept this letter as part of the business impact statement process required by Nevada Revised Statutes.

I would like to express our appreciation for the opportunity to provide our perspective with you and the Southern Nevada Health District staff during the agency's listening session. As I shared at that meeting, we have concerns regarding the proposed 29 percent increase in environmental health (EH) fees.

First, I think it is important to establish the backdrop this proposal is set against. While gaming revenues have increased, commercial activity at non-gaming areas of resorts continues to be below 2019 levels. Data recently released by the Las Vegas Convention and Visitors Authority (LVCVA) comparing February 2022 business activity to February 2019 show that the hospitality industry is still recovering. Visitation remains down 18 percent. Convention attendance is down 41 percent. The deplaned air passengers count is down 8 percent from pre-pandemic levels. Overall hotel occupancy is below 2019 levels, with midweek occupancy down 24 percentage points from February 2019. The data reflect the fact that international travel and tradeshow and convention business have not normalized, which is critical to midweek business, particularly at food and beverage outlets found in and around resort properties. The timing and the magnitude of the fee increase is challenging for operators trying to recover from this difficult period.

Furthermore, our members and all Southern Nevada businesses, large and small, are being impacted by inflation, gas prices, and lingering supply chain disruptions, which impact the costs of transportation and goods, as well as the ability of visitors and tourists to travel to our destination.

According to official data released just three days ago, the price of food items has increased by 8.5 percent for the 12-months ending March of this year, the largest 12-month increase since the period ending December 1981¹. Alarming, the price of certain food items, including certain meats, poultry,

and eggs, have increased by up to 18.2 percent in the past 12 months. Accelerating food prices not seen in more than four decades combined with an unprecedented 29 percent increase in EH fees will result in material adverse impacts to the recovering food establishment industry. Food and beverage establishments are also experiencing critical labor shortages that have affected hours of operations and capacity levels. While the resort industry continues to do all it can to fully recover, significant challenges remain.

Another area of concern with the current proposal focuses on the cost allocation of SNHD administrative functions to the Environmental Health Division (EH). The items included in these costs remain unclear. We would like to better understand the costs and whether other departments in the Health District have similar allocations. Further, we believe it is important to have a public policy discussion regarding whether it is appropriate that an allocation cover the non-fee providing activities of EH.

Similarly, we would also like to further discuss the merits of the fee-for-service model. We support the practice of paying fees for services provided by EH that are to the benefit of those requesting the services. However, when a fee is broadened to fund other functions that benefit the entire community and are unrelated to the service being rendered, it contradicts the fee-for-service principle. For example, we recognize EH conducts vital activities that protect public health and safety, such as vector monitoring, enforcement against illegal vendors, or illegal dumping of waste. Given the nature of these activities, they should be funded by other revenue sources within the Health District, not subsidized by fees paid by businesses requesting services directly related to their business operations, such as food permit, license, and inspection fees.

As previously mentioned, the current business environment continues to present challenges and unpredictability. With that in mind, we are deeply concerned by the size and timing of the proposed increase. Implementing a 29 percent increase in less than three months is unprecedented. Operators have already established annual budgets and are not prepared to absorb the impact of a 29 percent increase in fees, particularly while they are trying to recover.

We understand EH fees have not increased in some time. However, trying to catch up with one single, large increase would be economically devastating and further hinder our progress. If increases are warranted, it would be more reasonable to phase them in over time, as has been done by other public agencies in a similar position.


Further, we have deep reservations about the proposal to add automatic indexing into future fee increases. Even with set parameters around the percentages to address periods of high volatility and inflation, indexing presents challenges. This structure lacks a periodic opportunity for public accountability and transparency to review the performance of fees and whether they are meeting current needs.

Respectfully, we ask you to consider continuing to engage stakeholders in this process with additional public workshops and comment periods, as has been the practice of other public agencies when proposing rate and fee increases. As part of this engagement process, it would be helpful to see a rate comparison analysis with other similar communities to provide additional context.

In closing, we would like to reiterate that we do not oppose reasonable fees for service and recognize that the cost for certain public services should be paid for by the requesting business or entity. We appreciate the work EH does in the community and value the longstanding relationship we have with the Health District. We look forward to continuing to discuss this proposal to arrive at a reasonable resolution.

BACKGROUND

The Health District is responsible for state-mandated environmental health permitting and inspections in Clark County, Nevada. Some examples of Health District environmental health permits include permanent and temporary food operations; pools and spas; public accommodations; schools; childcare facilities; body art and tattoo shops; underground storage tanks; individual sewage disposal systems; and liquid waste haulers.

The EH division of the Health District has not had an overall fee adjustment approved by the Board of Health since 2009. As a result, permit fees have not changed while operating costs have increased. Please note, the Consumer Price Index has increased 33% over this same period of time.

PROPOSED CHANGES

The Health District proposes the following EH Fee Schedule adjustments effective July 1, 2022:

1. 29% fee increase to all fees on the EH Fee Schedule.
2. Tie the EH Fee Schedule to the Consumer Price Index (Western Region) with an annual adjustment of a 1% floor and a 3% ceiling beginning July 1, 2023.

These EH Fee Schedule adjustments will allow programs to keep up with increasing operating costs and continued community growth.

The proposed changes are projected to increase EH division revenue by \$5,870,654 in Fiscal Year 2023 (July 1, 2022 to June 30, 2023) and between 1-3% annually thereafter based on the Consumer Price Index.

PRESENTATION OF A BUSINESS IMPACT STATEMENT TO THE BOARD OF HEALTH

After considering all data and arguments received on the proposed fee adjustments, the Health District will make a determination as to the likely impact to business and prepare a Business Impact Statement.







Background

The Health District is responsible for state-mandated environmental health permitting and inspections in Clark County, Nevada. Some examples of Health District environmental health permits include permanent and temporary food operations; pools and spas; public accommodations; schools; childcare facilities; body art and tattoo shops; underground storage tanks; individual sewage disposal systems; and liquid waste haulers.

The EH division of the Health District has not had an overall fee adjustment approved by the Board of Health since 2009. As a result, permit fees have not changed while operating costs have increased. Please note, the Consumer Price Index has increased 33% over this same period of time.

Proposed Changes

The Health District proposes the following EH Fee Schedule adjustments effective July 1, 2022:

1. 29% fee increase to all fees on the EH Fee Schedule.
2. Tie the EH Fee Schedule to the Consumer Price Index (Western Region) with an annual adjustment of a 1% floor and a 3% ceiling beginning July 1, 2023.

These EH Fee Schedule adjustments will allow programs to keep up with increasing operating costs and continued community growth.

The proposed changes are projected to increase EH division revenue by \$5,870,654 in Fiscal Year 2023 (July 1, 2022 to June 30, 2023) and between 1-3% annually thereafter based on the Consumer Price Index.

Presentation of a Business Impact Statement to the Board of Health

After considering all data and arguments received on the proposed fee adjustments, the Health District will make a determination as to the likely impact to business and prepare a Business Impact Statement.

Pursuant to NRS 237.090, the Board of Health will consider the Business Impact Statement at a public meeting on Tuesday, May 3, 2022, at 2:00 p.m. At that time, it is anticipated that the Board of Health will set a PUBLIC HEARING for May 26, 2022, to consider approval of the proposed EH Fee Schedule adjustments or other possible action. 


EH COVID-19 Activities

- ▶ Developed COVID related informational pamphlets/resources for Industry at the start of the pandemic when such resources were not available at the Federal and State level. The COVID resources received appreciation and national recognition by Industry and other local health departments around the country.
- ▶ Collaborated with State and local Business License agencies on business reopening guidance and COVID compliance checks.
- ▶ Provided oversight and enforcement of the Governor's COVID-19 mitigation orders and Senate Bills (SB4 and SB386), including conducting thousands of COVID-19 Compliance Surveys.
- ▶ Conducted regular educational outreach to the Culinary Union, the Resort Association, the Nevada Hotel and Lodging Association and many other organizations on COVID regulatory changes and requirements.

- ▶ Participated in the National Association of County and City Health Officials (NACCHO) mentorship program (Staff mentored other Health Departments about the FDA's Retail Food Voluntary Standards program.)

Maximized Efficiencies:

- ▶ Monthly meetings with all field staff to discuss productivity and expectations (analyzing field time versus office time, ensuring staff are meeting goals/deadlines, and ensuring staff are making progress with assigned inspections)
- ▶ Focused efforts on high-risk food establishments due to staffing shortage
- ▶ Temporary reassignments of staff to meet community needs (inspections of large events, unpermitted food vending response, etc.)

- ▶ Split Aquatic Health Plan Review and Operations offices to allow plan review staff to focus full-time on plan review activities
- ▶ Streamlined inspections to focus on risk and reduce time spent on inspections



- ▶ Staff are not meeting policy requirements and mandates.


EH Revenue/Expenses

- ▶ Tie the EH Fee Schedule to the Consumer Price Index (Western Region) with a 1% floor / 3% ceiling annual adjustment to give programs sustainability as the community continues to grow.
