RE: *Approval of the Amendment to the Interlocal Agreement between the Southern Nevada Health District and The City of North Las Vegas.*

That the Southern Nevada District Board of Health *approves the Amendment to the Interlocal Agreement for acquisition and relocation of modular structures between the Southern Nevada Health District and The City of North Las Vegas.*

DISCUSSION:

The City of North Las Vegas shall acquire the two modular structures from SNHD at no cost. This Amendment amends the move date of the smaller modular structure (Asset #2) to January 15, 2026. The larger modular structure (Asset #1) will be moved as initially agreed upon by October 31, 2025.

FUNDING:

There is no funding associated with this Amendment. The City of North Las Vegas shall be responsible for all costs associated with the disassembly, transportation and reassembly of both modular structures.

**AMENDMENT ONE TO
INTERLOCAL AGREEMENT FOR ACQUISITION AND
RELOCATION OF MODULAR STRUCTURES**

This Amendment One to Interlocal Agreement for Acquisition and Relocation of Modular Structures (“Amendment One”), is made and entered into as of the date of the last signature affixed hereto (“Effective Date”) by and between the City of North Las Vegas, a Nevada Municipal corporation (“City”) and the Southern Nevada Health District, a political subdivision of the State of Nevada (hereinafter referred to as (“SNHD”)) (each, a “Party” and collectively, the “Parties”) for the purpose of the acquisition of surplus modular structures components and their relocation.

RECITALS

WHEREAS, on May 27, 2025, City and SNHD entered into an Interlocal Agreement for Acquisition and Relocation of Modular Structures (“Agreement”); and

WHEREAS, the Parties mutually desire to amend the removal date of Asset #2.

NOW, THEREFORE, pursuant to Section 5 of the Agreement, the Parties mutually agree to amend the Agreement as follows:

1. Subsection 1.2 of the Agreement is hereby deleted in its entirety and replaced with the following:

1.2 The City shall ensure the removal of Asset #1 no later than October 31, 2025 and the removal of Asset #2 no later than January 15, 2026 from SNHD’s property located at 280 South Decatur Boulevard Las Vegas, NV 89107.

2. This Amendment One may be executed in counterparts and all of such counterparts, taken together, shall be deemed part of one instrument.

Except as expressly provided in this Amendment One, all the terms and provisions of the Agreement are and will remain in full force and effect and are hereby ratified and confirmed by the Parties.
