

Public Accommodations Hotel/Motel, RV/MHP/SCRV

We are informing you of a proposed update to the existing SNHD Regulations Governing the Health and Safety of Public Accommodation Facilities. The Regulations have not been updated since their development in 2006 and our goal is to simplify and clarify the existing language, as well as make a small number of needed changes. A copy of the draft regulations, as well as a red-line document, list of major changes and appendices are below.

We are interested in your feedback regarding the proposed changes and have posted a survey where you can provide input on how these revisions may impact your business. **The survey closes on January 31, 2025.** A public workshop to discuss the proposed changes will be held in person on **January 23 from 1:00–2:00 p.m.** in the Red Rock conference room at the Main Public Health Center, 280 S. Decatur Blvd., Las Vegas, NV 89107.

Hotel/Motel

Hotels, motels, resorts, hostels, bed & breakfast facilities, transient rooming or lodging houses, and other buildings or structure kept as, used as, maintained as, or held out to the public to be, a place where sleeping or rooming accommodations are furnished to the transient public, require permitting and compliance with **NRS 447** and the **Regulations Governing the Health and Safety of Public Accommodation Facilities**.

New, Addition or Remodel:

As provided in **Section 3.1**, any person who begins the construction or extensive remodeling of a public accommodation facility that requires a building permit must submit the plans to the appropriate Health Authority for review and approval. At least 30 days prior to beginning construction or remodeling of a public accommodation facility, the responsible person must submit construction plans with all schedules; e.g., floor plans, elevations, electrical schematics, etc., to the Health Authority for review and approval. Please see **Plan Review** requirements for compliance requirements, **submission instructions**, and **applications**. Appointments can be made by calling and leaving a message at (702) 759-1633. Calls will usually be returned by the next business day.

Self Contained Recreational Vehicle (SCRV):

Hotels and motels that allow guests to park Recreational Vehicles in their parking lot for the purposes of overnight accommodations are required to apply for and obtain a separate health permit for SCRv parking. Hotels and motels seeking to obtain such permits may submit an **application** for a SCRv permit and meet the requirements outlined in **Regulations Governing the Health and Safety of Public Accommodation Facilities, Chapter 14**.

Change-of-Owner Process:

As provided in section 9.3.5, permits issued under this regulation are not transferrable from person to person or place to place. An **application** and **instruction sheet** must be submitted for a new permit on an existing Public Accommodation. Applications complete with supporting documentation (copy of lease agreement, deed, etc.) may be completed and e-

NOTICE OF INTENT TO ADOPT CHANGES TO THE REGULATIONS GOVERNING THE SANITATION AND SAFETY OF PUBLIC ACCOMMODATION FACILITIES IS HEREBY GIVEN. The Health District proposes updating these regulations to simplify and clarify existing language, as well as make other needed changes.

The Health District is currently accepting data and arguments regarding the potential impact of the proposed regulatory changes on businesses as provided in NRS 237. As part of this process, the Health District will hold one public WORKSHOP for interested parties to present their views regarding the potential business impact of the proposed 2025 Public Accommodation Regulations. The public workshop will be held on Thursday, January 23, 2025, at 1:00 p.m., in-person at the SNHD Public Health Center, 280 South Decatur Boulevard, Las Vegas, in the Red Rock Conference Room.
