BODY ART AND MICROBLADING CARDS

All artists in Clark County who provide body art services need to have either a body art card or a microblading card. A person with only microblading experience will be issued a microblading card and is limited to applying body art only to the face.

- Must be a minimum of 18 years of age
- Must have a minimum of six months experience or training
- Must possess current certification in infectious disease training
- Must complete the Body Art/Microblading Artist Application
- Must obtain a score of at least 80 percent on the Health District's 30-question, multiple-choice test in person at one of our Health Cards offices by appointment

APPRENTICE CARDS

Applicants who do not meet the six-month experience requirement must be in an apprenticeship for at least six months in a Health District permitted establishment working under a Mentor.

- Must be a minimum of 18 years of age
- Must possess current certification in infectious disease training
- Must complete the Apprentice Application and Employment Verification Form
- Must obtain a score of at least 80 percent on the Health District's 30-question, multiple-choice test in person at one of our Health Cards offices by appointment

After six months of training, submit a completed Experience Verification Form to have the apprentice card exchanged for the Body Art or Microblading Card.



MENTOR CARDS

A person who has held a Body Art Card for at least four years or can provide evidence of doing body art in a jurisdiction outside of Clark County can apply for a Mentor Card.

The Mentor Card will permit the holder to have
5 body art apprentices or 15 microblading apprentices.

- Must possess current certification in infectious disease training
- Must complete the Mentor Application
- Must bring the Body Art Card


MENTOR CARDS

Persons who held a valid Body Art Card on June 30, 2022, and do not have four years experience can apply for a Mentor Card if they do so by June 30, 2023.

- Must possess current certification in infectious disease training
- Must complete the Mentor Application
- Must bring the Body Art Card

PERMIT HOLDER'S JOINT RESPONSIBILITY

The permit holder has joint responsibility with the body artist in ensuring that each individual they hire or consent to take as an apprentice obtains a body art card in accordance with these Regulations. Allowing individuals to practice as a body artist within a body art establishment without a valid body art card is grounds for enforcement action, up to and including suspension of the health permit for the body art establishment.
