# VII. <u>INFORMATIONAL ITEMS/ DISCUSSION ONLY</u>

A. "HIV/STI risk among secondary students in Nevada" results from Nevada YRBS - Dr. Kristen Clements-Nolle -UNR

See presentation titled "HIV/STI Risk Among Secondary Students in Nevada: 2023 YRBS Results"

- Nevada schools comprise the survey 36 schools participated
- Significant decline in sexual activity among secondary students in Nevada from 2003 to 2023
- Decrease in students who had sex with 4+ persons
- Decrease in students who has sex within last 3 months
- Lack of improvement in condom use
- Rates of substance use before sexual encounters
- Importance of using weighted data for local prevention planning
- Correlation between housing insecurity and increased risk behaviors among students
- Protective factors of school connectedness and family communication in mitigating risky behaviors – ACE and PCE (Adverse Childhood Experience and Protective Childhood Experiences)
- Better data collection needed on housing insecurity and ACE
- Better data collection needed for rural and frontier communities
- YRBS study CDC funded specific procedures/guidelines

C: Check substance use data in youth – HS students seem to be dropping in numbers, but youth are increasing

C: Housing data is extremely important; it should be collected as a standard

C: Early initiation of sex – PrEP should be offered

Dr. Clements-Nolle will be sampling tribal schools in 2025 to ensure sufficient data collection for the survey.

Dr. Clements-Nolle is interested in legislative issues so contact her for inquiries and she can pull the data needed.

C. "Long-Acting HIV Prevention in Women" - Karla Torres and Natalie Nix-ViiV Healthcare \*Karla Torres was unable to join.

See presentation titled "CAB LA for Prevention" \*\*NOTE: This presentation is for HPPG and not for further distribution.

- 1.2 million people living with HIV since 2021
- 32,000 new diagnoses in 2022
- Goal: 75% reduction by 2025; 90% reduction by 2030
- 64% of eligible persons not receiving PrEP
- Sexual health discussion tools available for providers
- Research study 984 participants; 73% women of which 30% aged 15-24
  - HPTN 084 Pregnancy study OLE phase data on pregnant and breastfeeding women who stopped taking PrEP
  - HPTN 084-01 adolescent females under age 18
  - HPTN 083 transgender women who have sex with men
  - HIV testing HIVRNA required to confirm negative results due to high rate of false positives; RNA is expensive and could be a barrier for some patients

Q: If a positive RNA with a viral load of <200; is the recommendation to repeat the test? A: Yes, repeat the RNA test to confirm.

- Apertude is the only long acting injectable with a 2-month coverage. It works incredibly well in cis-gender women and is highly preferred among men and women.
- CAB LA is the first LAI PrEP with 2-month coverage, proven superiority to daily oral TDF/FTC in CGW, MSM, and TGW with high preference
- Data from HPTN 083 OLE phase supports a high preference for CAB LA across Latin America, Asia, Africa, and the US
- Convenience and adherence considerations were amongst the top reasons for adopting CAB LA in PILLSR proactive provider conversations, which may enable broader PreP uptake in MSM and TGM
- CAB LA PrEP is well-tolerated during pregnancy and is unlikely to require dosemodification; however, the label indicated that injections are not recommended during pregnancy unless the benefit justifies the potential risk to the fetus
- Regular RNA screening in HPTN 083, while highly sensitive, led to false positives that should be followed up and confirmed through additional testing

- Sexual Health Fair at SNHD held September 3, 2024 tested over 15 patients in Express Testing and 13 in Mobile unit. The next day we had a lot of clients testing.
- SHOPP offers free testing for all STIs and HCV at Decatur M-Th, and at Fremont on Fridays. We go out to encampments, we offer linkage with Rapid stART and other services, we work alongside NV Homeless Alliance and attend events, and access HMIS to help with alerts on out-of-care clients. We offer free case management and navigation services for congenital syphilis cases, and project NEON for cases with neurosyphilis. The newest initiative is with Clark County Social Services Department providing non-medical case management as a whole person approach. Help navigate multiple services including PrEP.
