WEEKLY ARBOVIRUS UPDATE

Clark County, NV.

In an effort to keep Clark County residents and visitors safe and aware of the arboviruses currently affecting the area, the Southern Nevada Health District (SNHD) is issuing a weekly arbovirus update. SNHD conducts routine surveillance for arboviruses in mosquitoes and arboviral disease in humans. SNHD's Mosquito Surveillance program monitors the local mosquito population for arboviruses such as West Nile Virus (WNV), St. Louis Encephalitis Virus (SLEV), and Western Equine Encephalitis Virus (WEEV). In addition to monitoring mosquitoes for arboviruses, the program also provides information on the type of mosquitoes present in the area.

Arboviral diseases in humans are reportable to SNHD's Office of Acute Communicable Disease Control (ACDC). Currently, WNV and SLEV are the only locally acquired arboviral diseases that have been reported. ACDC sporadically investigates travel-associated cases of dengue, chikungunya, and Zika virus.

West Nile Virus

WNV is a potentially serious but preventable illness most often spread by the bite of an infected mosquito. It is the leading cause of mosquito-borne disease across the United States.

Mosquitoes become infected when they feed on infected birds. WNV can infect humans, birds, mosquitoes, horses, and some other mammals. It is not transmitted from person-to-person.

According to the Centers for Disease Control and Prevention (CDC), about 1 in 5 people who are infected develop a fever and other symptoms. About 1 out of 150 infected people develop serious, sometimes fatal, illness.

The most effective way to prevent arboviral infections, such as WNV, is to prevent mosquito bites and eliminate standing water.

WNV Activity

Currently, ACDC has zero active WNV investigations. In 2026, ACDC completed 3 WNV investigations. So far this year, there has been 1 case identified, 1 hospitalization and zero deaths.

SLEV Activity

Currently, ACDC has zero active SLEV investigations. In 2026, ACDC completed zero SLEV investigations. So far this year, there have been zero cases identified, zero hospitalizations and zero deaths.

WEEV Activity

Currently, ACDC has zero active WEEV investigations. In 2026, ACDC completed zero WEEV investigations. So far this year, there have been zero cases identified, zero hospitalizations and zero deaths.

Mosquito Surveillance

In 2026, SNHD Environmental Health has set 1,852 traps throughout Clark County and submitted 1,951 sample pools*, representing 37,915 mosquitoes, to the Southern Nevada Public Health Lab (SNPHL) for arboviral analysis. Of these sample pools submitted, 47 tested positive for WNV, zero tested positive for SLEV, and zero tested positive for WEEV.

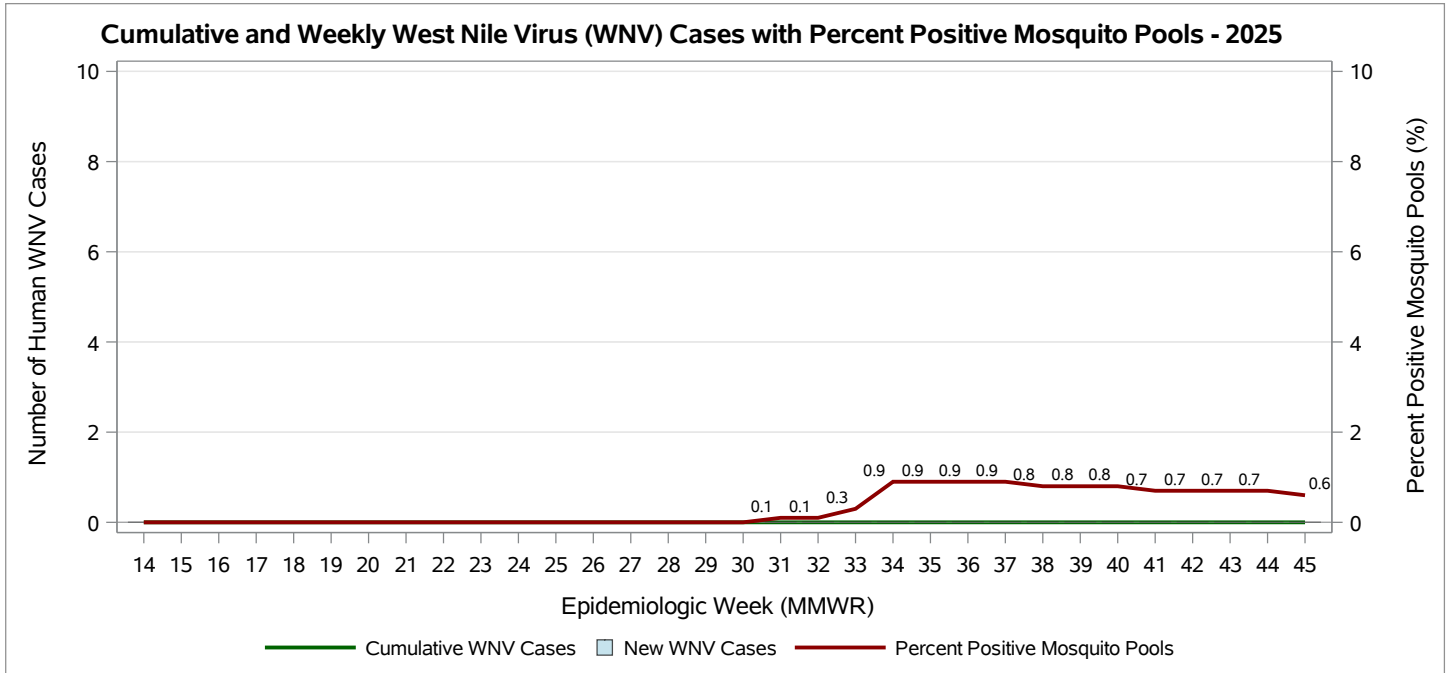

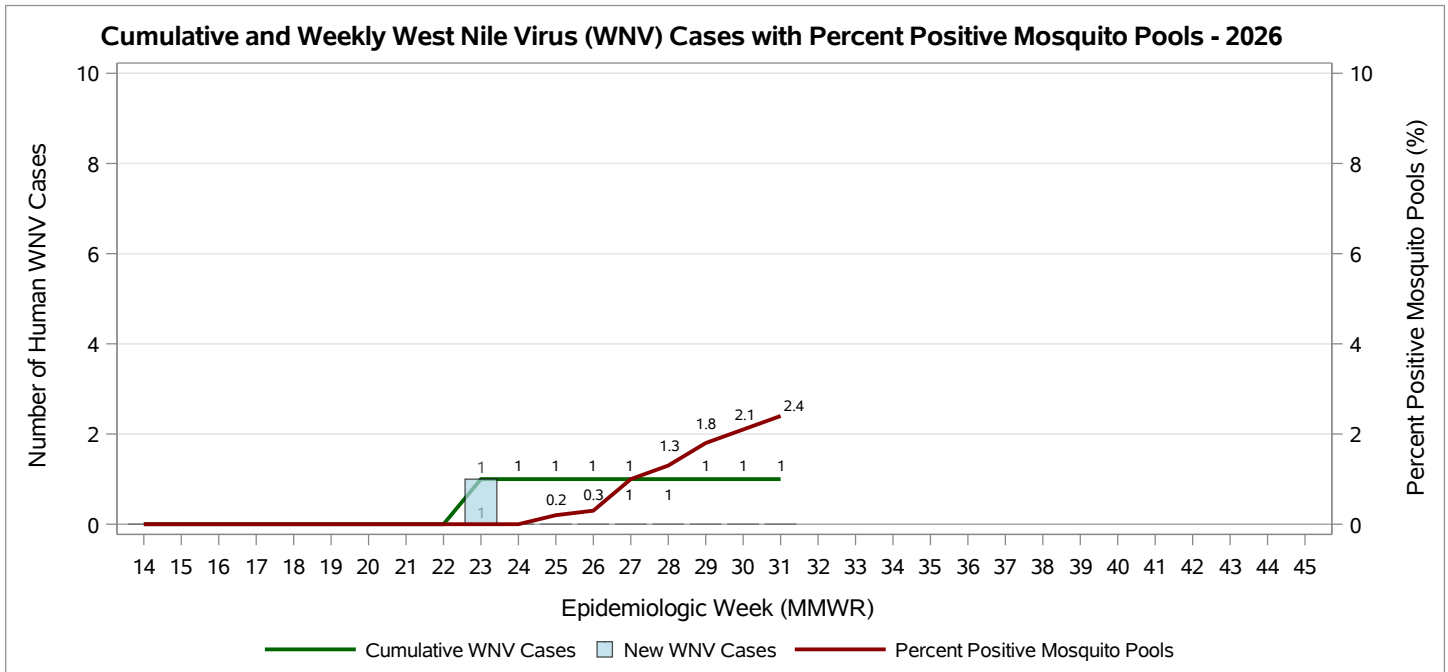

*A sample pool is defined as a group of up to 50 female mosquitoes of the same species collected from a single location and combined into one vial for testing. **Note: 2026 data are preliminary and subject to change.** Case counts are based on CDC surveillance case definitions.

2025 Mosquito Activity Summary



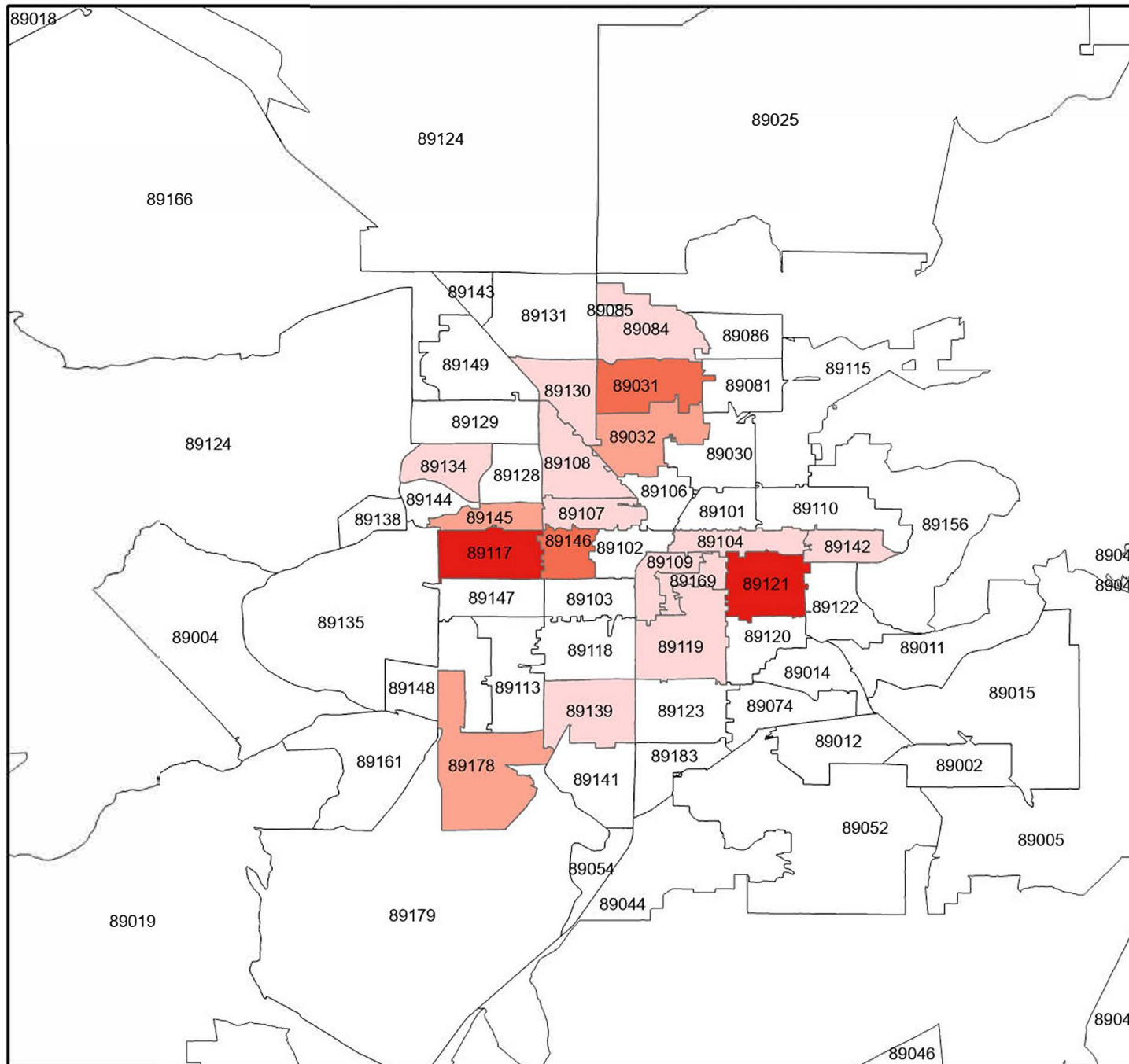

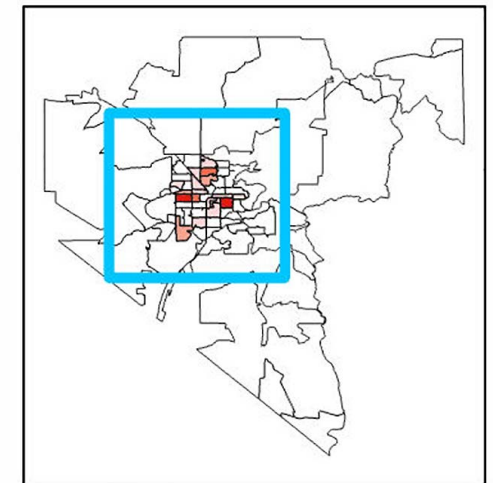
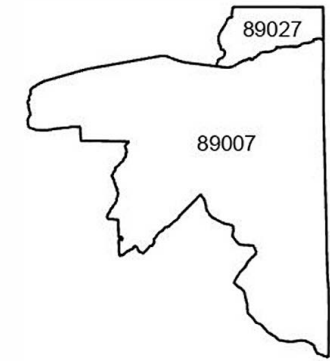
Definitions:

- **Percent Positive Mosquito Pools:** Cumulative percent of mosquito pools testing positive for WNV across the season.

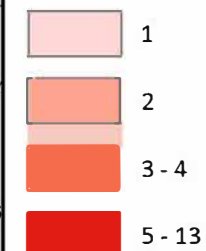
West Nile Virus Activity, Clark County, NV
