

## **PUBLIC NOTICE**

NOTICE IS HEREBY GIVEN that a *Business Impact Survey* to make comments on a proposed *Individual Sewage Disposal System (ISDS) Operating Permit Fee* is available. This is a follow-up Business Impact Survey to the one done for the proposed Individual Sewage Disposal System and Liquid Waste Management Regulations between March 16, through April 27, 2025. Comments received during this comment period for the proposed ISDS Operating Permit Fee will be used to complete the *Business Impact Statement (BIS)* pursuant to Nevada Revised Statute (NRS) 237.080. As part of this process, the Health District will hold one public WORKSHOP for interested parties to present their views regarding the proposed *ISDS Operating Permit Fee of \$226 per 5-year permit cycle*. The public workshop will be held on Wednesday, July 23, 2025, at 1:00 p.m., in-person at the SNHD Public Health Center, 280 South Decatur Boulevard, Las Vegas, in the Red Rock Conference Room.

Business owners and interested parties may submit data, views, and comments as to whether the proposed ISDS Operating Permit Fee of \$226 per 5-year permit cycle will impose a direct and/or significant economic burden upon a business or directly restrict the formation, operation, or expansion of a business. A summary of all comments submitted by July 31, 2025, to Nancy Cadena, Administrative Specialist, Southern Nevada Health District, 280 South Decatur Boulevard, Las Vegas, Nevada 89107, or emailed to <u>cadena@snhd.org</u> will be included in the BIS presented to the Southern Nevada District Board of Health (BOH). All interested persons may appear at the BOH PUBLIC HEARING and submit data, views, or arguments regarding the BIS and proposed ISDS Operating Permit Fee. The BOH will consider fully all written and oral submissions prior to taking action thereon.

A Public Hearing to review and take testimony on the BIS for the proposed ISDS Operating Permit Fee will be held before the BOH on Thursday, August 28, 2025 at 9:00 a.m. in the Red Rock Conference Room at the Southern Nevada Health District (SNHD) Public Health Center located at 280 South Decatur Boulevard, Las Vegas, Nevada and/or virtually at the same date and time, pursuant to NRS 239.090. A Public Hearing to review and approve the proposed ISDS Operating Permit Fee is expected to be held before the BOH on Thursday, October 23, 2025, at 9:00 a.m. in the Red Rock Conference Room at the SNHD Public Health Center located at 280 South Decatur Boulevard, Las Vegas, Nevada and/or virtually at the same date and time.
