

## **PUBLIC NOTICE**

THIRTY DAY NOTICE OF INTENT TO ADOPT CHANGES TO THE REGULATIONS GOVERNING INDIVIDUAL SEWAGE DISPOSAL SYSTEMS AND LIQUID WASTE MANAGEMENT IS HEREBY GIVEN. The Southern Nevada Health District proposes updating the regulations to simplify and clarify existing language, as well as making other needed changes. Some of the major changes include issuance of septic system operating permits that will expire on a five-year cycle and require a renewal fee; allow facilities with a permanent commercial holding tank the opportunity to change from an annual temporary to a permanent operating permit; and requiring well water testing and septic system inspections during real estate transactions.

Members of the public may submit written comments regarding the proposed regulation changes by e-mailing septics@snhd.org or submitting written comments no later than October 3, 2025, for consideration prior to the PUBLIC HEARING. Additionally, public comments may be provided during WORKSHOPs and the PUBLIC HEARING.

Prior to the PUBLIC HEARING, there will be WORKSHOPs for the public to present their views regarding the proposed 2025 Individual Sewage Disposal Systems and Liquid Waste Management Regulations. These WORKSHOPs will be held on the following dates/times at the following locations.
